for the Hammer-Country Club 60kV Power Line Relocation in the City  
of Stockton**

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

**Purpose**

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

**Background**

In order to accommodate a road widening project in the City of Stockton, PG&E has been requested by La Morada Partnership L.L.C. to relocate approximately 1.5 miles of the existing Hammer-Country Club 60kV power line in the City of Stockton. PG&E will relocate the line from its present location on the east side of West Lane and the north side of Morada Lane to a new location approximately 40' to the east (existing franchise) of the present location on West Lane between Bear Creek and Morada Lane, and approximately 50' to the north (existing franchise) of the present location on Morada Lane between West Lane and Mosher Creek. To ensure adequate conductor clearance over proposed city street lights and signal lights, approximately 26 wood poles will be replaced with taller wood poles (replacement of existing facilities). Most of the poles, which currently range from approximately 60-70 feet tall, will be replaced with approximately 10-feet taller poles. Eight poles will be approximately 15' taller, and four poles will be approximately 20-25' taller to allow adequate clearance. In addition, one 85' steel pole will be replaced with a 10' taller wood pole, and one 45' tall wood pole will be replaced with a 30' taller wood pole to provide sufficient clearance for the adjacent railroad. One new 80' wood pole will be interset (intersetting of additional support structures) on the southeast corner of Morada Lane and West Lane to provide

adequate line clearance over proposed signal lights. Construction is scheduled to begin in June 2008 or as soon thereafter as possible, with completion in approximately four weeks or as soon as possible after construction begins

- This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, Subsection B.1., which exempts, “The minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures”, “The replacement of existing power line facilities or supporting structures with equivalent facilities or structures”, and “Power line facilities or substations to be located in an existing franchise, road widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.”

## NOTICE OF PROPOSED CONSTRUCTION

**PROJECT NAME: HAMMER-COUNTRY CLUB 60KV POWER LINE RELOCATION, CITY OF STOCKTON**

**Proposed Project:** In order to accommodate a road widening project in the City of Stockton, PG&E has been requested by La Morada Partnership L.L.C. to relocate approximately 1.5 miles of the existing Hammer-Country Club 60kV power line in the City of Stockton. **Exemption from CPUC Permit Requirement:** CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption:

- The minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.
- The replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

**Public Review Process:** Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
