for the Cogeneration National 60kV Interconnection Project in the  
City of Stockton**

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

**Purpose**

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

**Background**

Pacific Gas and Electric Company (PG&E) has been requested by Pacific Ethanol to connect the proposed Pacific Ethanol Production and Transshipment Facility to the existing Cogeneration National 60kV power line. PG&E proposes to install approximately 2,100' of new 60kV line and overbuild approximately 750' of existing 12kV distribution line which is located in an industrial area of the Stockton Port District approximately two miles west of the intersection of Interstate 5 and Highway 4 (Crosstown Freeway) and approximately 1 mile north of Highway 4 (Charter Way) in the City of Stockton. The new line will tap off the existing Cogeneration National 60kV power line on Washington Street, extending west approximately 2,100' on the south side of Washington Street to Navy Drive on six approximately 55' – 65' tall new wood poles and one approximately 100' tall new wood pole. Two wood poles approximately 55' tall and 65' tall on the existing Cogeneration National 60kV line will be replaced with 20' and 40' taller wood poles needed to clear an existing overhead conveyor belt that crosses Washington Street. At the intersection of Washington Street and Navy Drive, the line will be co-located with the existing Rough and Ready Island 12kV distribution line and extend southeast along Navy Drive approximately 750' to Pacific Ethanol property. Three wood poles on the existing Rough and Ready Island 12kV distribution line on Navy Drive will be replaced with approximately 5' – 15' taller wood poles, and

one 45' tall wood pole will be replaced with an approximately 30' taller wood pole to ensure mandated minimum ground to conductor clearances. The line will extend an additional 900 feet on two poles on Pacific Ethanol property. Construction is scheduled to begin in August 2008 or as soon thereafter as possible, with completion in September 2008 or as soon as possible after construction begins.

- This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, Subsection B.1., which exempts, "Power lines or substations to be relocated or constructed which have undergone environmental review pursuant to CEQA as part of a larger project, and for which the final CEQA document (Environmental Impact Report (EIR) or Negative Declaration) finds no significant unavoidable environmental impacts caused by the proposed line or substation."

## NOTICE OF PROPOSED CONSTRUCTION

**PROJECT NAME: COGENERATION NATIONAL 60KV INTERCONNECTION PROJECT (CITY OF STOCKTON)**  
**ADVICE LETTER NUMBER: 3283-E**

**Proposed Project:** Pacific Gas and Electric Company (PG&E) has been requested by Pacific Ethanol to connect the proposed Pacific Ethanol Production and Transshipment Facility to the existing Cogeneration National 60kV power line. PG&E proposes to install approximately 2,100' of new 60kV line and overbuild approximately 750' of existing 12kV distribution line which is located in an industrial area of the Stockton Port District approximately two miles west of the intersection of Interstate 5 and Highway 4 (Crosstown Freeway) and approximately 1 mile north of Highway 4 (Charter Way) in the City of Stockton. The new line will tap off the existing Cogeneration National 60kV power line on Washington Street, extending west approximately 2,100' on the south side of Washington Street to Navy Drive on six approximately 55' – 65' tall new wood poles and one approximately 100' tall new wood pole. **Exemption from CPUC Permit Requirement:** CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption:

- Power lines or substations to be relocated or constructed which have undergone environmental review pursuant to CEQA as part of a larger project, and for which the final CEQA document (Environmental Impact Report (EIR) or Negative Declaration) finds no significant unavoidable environmental impacts caused by the proposed line or substation

The Pacific Ethanol Production and Transshipment Facility FEIR was certified in January 2007, and an Addendum was approved by the Port of Stockton on June 16, 2008 (SCH#2006062102). No significant unavoidable environmental impacts from PG&E's project were identified.

**Public Review Process:** Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
