Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

In order to accommodate the new Panoche Energy Center generation project in southwest Fresno County, providing an additional 400 megawatts of electrical power to Central Valley customers, the Company has been requested to perform necessary network upgrades, which include replacing the existing wires (conductors) with new wires (reconductor) on approximately one mile of the Wilson-Gregg 230 kilovolt transmission line located in rural Madera County (placing of new conductors). The reconductoring of the existing transmission line, which is in an existing easement (existing public utility easement), will occur along the existing route beginning near Gregg Substation, located along Avenue 7 approximately 1.5 miles east of State Route 99, and extending northwesterly approximately 1 mile, all within the County of Madera. The Company will not be raising or replacing any towers. Work will begin in September 2008, or as soon thereafter as possible, and will be completed by November 2008, or as soon thereafter as possible.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemptions:

- e) the placing of new or additional conductors, insulators, or their accessories on supporting structure already built
- g) power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

NOTICE OF PROPOSED CONSTRUCTION

PROJECT NAME: Wilson-Gregg 230 Kilovolt Transmission Line Reconductoring, County of Madera
ADVICE LETTER NUMBER: 3287-E

Proposed Project: In order to accommodate the new Panoche Energy Center generation project in southwest Fresno County, providing an additional 400 megawatts of electrical power to Central Valley customers, Pacific Gas and Electric Company (PG&E) has been requested to perform necessary network upgrades, which include replacing the existing wires (conductors) with new wires (reconductor) on approximately one mile of the Wilson-Gregg 230 kilovolt transmission line located in rural Madera County (placing of new conductors). The reconductoring of the existing transmission line, which is in an existing easement (existing public utility easement), will occur along the existing route beginning near Gregg Substation, located along Avenue 7 approximately 1.5 miles east of State Route 99, and extending northwesterly approximately 1 mile, all within the County of Madera. PG&E will not be raising or replacing any towers. Work will begin in September 2008, or as soon thereafter as possible, and will be completed by November 2008, or as soon thereafter as possible.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption:

- e) the placing of new or additional conductors, insulators, or their accessories on supporting structure already built.
- g) power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

- 1. Your name, mailing address and daytime telephone number.
- 2. Reference to the CPUC Advice Letter Number and Project Name.
- 3. A clear description of the reason for the protest.
- 4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.

Within 30 days after Pacific Gas and Electric Company has submitted its response, the Executive Director of the CPUC will send you a copy of an Executive Resolution granting or denying the request and stating the reasons for the decision.
