**Subject: Submits Notice of Construction, Pursuant to General Order 131-D,  
for the Reconductoring of the Wilson-Oro Loma 115 Kilovolt Power  
Line, County of Merced**

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

**Purpose**

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

**Background**

In order to accommodate the new Panoche Energy Center generation project in southwest Fresno County, providing an additional 400 megawatts of electrical power to Central Valley customers, the Company has been requested to perform necessary network upgrades, which include replacing the existing wires (conductors) with new wires (reconductor) on approximately 5 miles of the Wilson-Oro Loma 115 kilovolt power line located in rural Merced County just south of the City of Merced (placing of new conductors). The reconductoring of the existing power line, which is in the franchise of Healy Road (existing franchise), will occur along the existing route beginning near the intersection of Healy Road and Vassar Avenue and extending southerly along Healy Road approximately 5 miles to the intersection of Healy Road and Sandy Mush Road, all within the County of Merced. The Company will be replacing approximately 55 existing wood poles (approximately 60 feet in height) with approximately 86 wood poles (approximately 65 feet in height) (replacement of existing power line facilities, intersetting of additional support structures). The extra poles are required to shorten the spans to support the larger conductors and comply with the Commission's General Order 95. Work will begin in September 2008, or as soon

thereafter as possible, and will be completed by November 2008, or as soon thereafter as possible.

**Exemption from CPUC Permit Requirement:** CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemptions:

- b) the replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- c) the minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing structures.
- e) the placing of new or additional conductors, insulators, or their accessories on supporting structure already built
- g) power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

**Proposed Project:** In order to accommodate the new Panoche Energy Center generation project in southwest Fresno County, providing an additional 400 megawatts of electrical power to Central Valley customers, Pacific Gas and Electric Company (PG&E) has been requested to perform necessary network upgrades, which include replacing the existing wires (conductors) with new wires (reconductor) on approximately 5 miles of the Wilson-Oro Loma 115 kilovolt power line located in rural Merced County just south of the City of Merced (placing of new conductors). **Public Review Process:** Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

- 1. Your name, mailing address and daytime telephone number.
- 2. Reference to the CPUC Advice Letter Number and Project Name.
- 3. A clear description of the reason for the protest.
- 4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
