Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

The Company has been requested by the developer of subdivision tract 5512 in the City of Fresno to relocate approximately 1,730 feet of the Kearney-Biola 70kV Power Line (minor relocation) to allow improvements to Cornelia Avenue from Clinton Avenue to Cornell Avenue in the City of Fresno. The Company will relocate approximately 6 wood power poles (replacement of existing facilities) approximately 15 feet easterly along the easterly side of Cornell Avenue (existing franchise) between Clinton Avenue and Cornell Avenue. Most poles will be increased approximately 5' in height (most existing poles are approximately 55' tall); the northerly two will increase approximately 15' in height (70' tall) to match the height of the other existing power poles. In addition, the Company will remove three existing wood stub poles along the westerly side of Cornelia Avenue and, approximately 400 feet northerly of Clinton Avenue, install one new 35-foot tall wood stub pole with guy wires crossing Cornelia Avenue. Work is planned to commence as early as September 2008, or as soon thereafter as possible, and should be completed by December 2008, or as soon thereafter as possible.

CPUC General Order 131-D, Section III, Subsection B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption(s),

- b) the replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- c) the minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.
- g) power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

NOTICE OF PROPOSED CONSTRUCTION

PROJECT NAME: Kearney-Biola 70 Kilovolt (70kV) Power Line Relocation, County of Fresno
ADVICE LETTER NUMBER: 3296-E

Proposed Project: Pacific Gas and Electric Company (PG&E) has been requested by the developer of subdivision tract 5512 in the City of Fresno to relocate approximately 1,730 feet of the Kearney-Biola 70kV Power Line (minor relocation) to allow improvements to Cornelia Avenue from Clinton Avenue to Cornell Avenue in the City of Fresno. PG&E will relocate approximately 6 wood power poles (replacement of existing facilities) approximately 15 feet easterly along the easterly side of Cornell Avenue (existing franchise) between Clinton Avenue and Cornell Avenue. Most poles will be increased approximately 5' in height (most existing poles are approximately 55' tall); the northerly two will increase approximately 15' in height (70' tall) to match the height of the other existing power poles. In addition, PG&E will remove three existing wood stub poles along the westerly side of Cornelia Avenue and, approximately 400 feet northerly of Clinton Avenue, install one new 35-foot tall wood stub pole with guy wires crossing Cornelia Avenue. Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption(s):

- b) the replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- c) the minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.
- g) power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

- 1. Your name, mailing address and daytime telephone number.
- 2. Reference to the CPUC Advice Letter Number and Project Name.
- 3. A clear description of the reason for the protest.
- 4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
