Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

Pacific Gas and Electric Company has been requested by the City of Fresno to replace 4 wood power poles (replacement of existing facilities) with 4 new light-duty steel poles in the existing Las Palmas Tap 115 kilovolt power line to accommodate the City's Clovis Avenue street improvement project. Two poles are located at the northeast corner and the northwest corner of Clovis Avenue and Olive Avenue (existing franchise) and the two other poles are located on the west side of Clovis Avenue (existing franchise) approximately 285' and 630' south of Olive Avenue. In order to maintain legal clearances over the new city improvements, the poles will increase in height approximately 20' (existing poles are approximately 60' to 65' tall), and the existing 75' tall wood pole on the northwest corner of Clovis Avenue and Olive Avenue will increase approximately 25'. Work is scheduled to begin in October 2008, or as soon thereafter as possible, and will be completed by February 2009, or as soon thereafter as possible.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption:

- b) the replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- g) power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

Anyone wishing to protest this filing may do so by filing a protest with the CPUC and the Company by **September 15, 2008**, which is 21 days after the date of this filing.¹ Protests should be mailed to the following address:

NOTICE OF PROPOSED CONSTRUCTION

PROJECT NAME: Las Palmas Tap 115kV Relocation, City of Fresno, Fresno County
ADVICE LETTER NUMBER: 3324-E

Proposed Project: Pacific Gas and Electric Company (PG&E) has been requested by the City of Fresno to replace 4 wood power poles (replacement of existing facilities) with 4 new light-duty steel poles in the existing Las Palmas Tap 115 kilovolt power line to accommodate the City's Clovis Avenue street improvement project. Two poles are located at the northeast corner and the northwest corner of Clovis Avenue and Olive Avenue (existing franchise) and the two other poles are located on the west side of Clovis Avenue (existing franchise) approximately 285' and 630' south of Olive Avenue. In order to maintain legal clearances over the new city improvements, the poles will increase in height approximately 20' (existing poles are approximately 60' to 65' tall), and the existing 75' tall wood pole on the northwest corner of Clovis Avenue and Olive Avenue will increase approximately 25'. Work is scheduled to begin in October 2008, or as soon thereafter as possible, and will be completed by February 2009, or as soon thereafter as possible.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption(s):

- b) the replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- g) power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist:

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
