Subject: Submits Notice of Construction, Pursuant to General Order 131-D, for the Construction of Nicolaus–Marysville 60 kV Conductor Replacement Project in the County of Yuba

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

In order to continue delivering safe and reliable electric service to homes and businesses within the vicinity of Marysville in Yuba County, Pacific Gas and Electric Company (PG&E) is proposing to replace the existing copper wires (conductor) with new aluminum conductor on a section of the existing Nicolaus – Marysville 60 Kilovolt (kV) Transmission Line (replacement of existing facilities). The work will take place between PG&E’s Marysville Substation, located at 4th and A Streets in Marysville, and the intersection of Plumas Arboga Road and Old Marysville Road in Olivehurst, a distance of approximately 9 miles. In order to replace the conductor, PG&E will need to replace approximately 75 wood poles with poles of similar heights (replacement of existing facilities) within the existing easement (existing easement). Two additional existing structures on either side of the Yuba River will be replaced (replacement of existing facilities) with tubular steel poles of approximately the same height. Construction is set to begin in October 2008, or as soon as possible thereafter, and project completion is scheduled for December 2009, or as soon as possible thereafter.

This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, Subsection B.1. which exempts “power line facilities or substations to be located in an existing franchise, road-widening setback easement, or

public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts” and “the replacement of existing power line facilities or supporting structures with equivalent facilities or structures.”

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

Anyone wishing to protest this filing may do so by filing a protest with the CPUC and the Company by **September 18, 2008**, which is 20 days after the date of this filing. Protests should be mailed to the following address:

Proposed Project: In order to continue delivering safe and reliable electric service to homes and businesses within the vicinity of Marysville in Yuba County, Pacific Gas and Electric Company (PG&E) is proposing to replace the existing copper wires (conductor) with new aluminum conductor on a section of the existing Nicolaus – Marysville 60 Kilovolt (kV) Transmission Line (replacement of existing facilities). The work will take place between PG&E's Marysville Substation, located at 4th and "A" Streets in Marysville, and the intersection of Plumas Arboga Road and Old Marysville Road in Olivehurst, a distance of approximately 9 miles. In order to replace the conductor, PG&E will need to replace approximately 75 wood poles with poles of similar heights (replacement of existing facilities) within the existing easement (existing easement). Two additional existing structures on either side of the Yuba River will be replaced (replacement of existing facilities) with tubular steel poles of approximately the same height. Construction is set to begin in October 2008, or as soon as possible thereafter, and project completion is scheduled for December 2009, or as soon as possible thereafter.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption:

- The replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- Power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist:

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.

Within 30 days after Pacific Gas and Electric Company has submitted its response, the Executive Director of the CPUC will send you a copy of an Executive Resolution granting or denying the request and stating the reasons for the decision.
