Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

The Company has been requested by the State of California Department of Transportation (Caltrans) to replace 4 wood power poles (replacement of existing facilities) with 4 new wood poles on the existing Henrietta-Kingsburg 115 kilovolt power line to accommodate the Caltrans' Highway 198 widening project. All 4 poles are located on the west side of 7th Avenue (existing franchise) in Kings County; one is approximately 50 feet north of the existing Highway 198; a second pole is approximately 330 feet north and will be moving southerly, along the existing pole line, approximately 20 feet; a third pole is located approximately 210 feet south of the existing Highway 198 and will be moving southerly, along the existing pole line, approximately 90 feet; the fourth pole is located approximately 600 feet south of the existing Highway 198 and will be moving northerly, along the existing pole line, approximately 45 feet. In order to maintain legal clearances over the new Caltrans improvements, the poles will increase in height approximately 5 feet to 15 feet (existing poles are approximately 65-75 feet tall). Work is scheduled to begin in November 2008, or as soon thereafter as possible, and will be completed by May 2009, or as soon thereafter as possible.

CPUC General Order 131-D, Section III, Subsection B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption(s):

- b) the replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- g) power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

Anyone wishing to protest this filing may do so by filing a protest with the CPUC and the Company by **October 20, 2008**,¹ which is 21 days after the date of this filing. Protests should be mailed to the following address:

NOTICE OF PROPOSED CONSTRUCTION

PROJECT NAME: Henrietta-Kingsburg 115kV Power Line Relocation, County of Kings
ADVICE LETTER NUMBER: 3346-E

Proposed Project: Pacific Gas and Electric Company (PG&E) has been requested by the State of California, Department of Transportation (Caltrans) to replace 4 wood power poles (replacement of existing facilities) with 4 new wood poles on the existing Henrietta-Kingsburg 115 kilovolt power line to accommodate the Caltrans' Highway 198 widening project. All 4 poles are located on the west side of 7th Avenue (existing franchise) in Kings County; one is approximately 50 feet north of the existing Highway 198; a second pole is approximately 330 feet north and will be moving southerly, along the existing pole line, approximately 20 feet; a third pole is located approximately 210 feet south of the existing Highway 198 and will be moving southerly, along the existing pole line, approximately 90 feet; the fourth pole is located approximately 600 feet south of the existing Highway 198 and will be moving northerly, along the existing pole line, approximately 45 feet. In order to maintain legal clearances over the new Caltrans improvements, the poles will increase in height approximately 5 feet to 15 feet (existing poles are approximately 65-75 feet tall). Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption(s):

- b) the replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- g) power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

- 1. Your name, mailing address and daytime telephone number.
- 2. Reference to the CPUC Advice Letter Number and Project Name.
- 3. A clear description of the reason for the protest.
- 4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
