Subject: Submits Notice of Construction, Pursuant to General Order 131-D, for the Soledad #1 60 kV Pole Replacement, County of Monterey

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

As part of on going maintenance efforts, the Company is proposing to replace approximately 10 wooden poles with new wooden poles of approximately the same height (replacement of existing facilities) along an approximately one-mile section of its Soledad #1 60kV Power Line. The project is located in an industrial/commercial area in the City of Gonzales along the westerly side of Alta Street between Foleta and 10th Streets in an existing franchise. The new poles will maintain the same height, with the exception of two that will be raised approximately 5 feet taller than the existing poles to ensure compliance with the CPUC's General Order 95 clearance requirements.

Construction is expected to begin in fall 2008, or as soon possible thereafter, and to be completed by March of 2009 or as soon as possible thereafter.

This project qualifies as exempt from Permit to Construct filing requirements,

pursuant to G.O. 131-D, Section III, Subsection B.1 which exempts:

- The replacement of existing power line facilities or supporting structures with equivalent facilities or structure.
- Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.”

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

Anyone wishing to protest this filing may do so by filing a protest with the CPUC and the Company by **November 3, 2008**, which is 20 days after the date of this filing. Protests should be mailed to the following address:

NOTICE OF PROPOSED CONSTRUCTION

ADVICE LETTER NUMBER: 3350-E

Proposed Project: As part of ongoing maintenance efforts, Pacific Gas and Electric Company (PG&E) is proposing to replace approximately 10 wooden poles with new wooden poles of approximately the same height (replacement of existing facilities) along an approximately one-mile section of its Soledad #1 60kV Power Line. The project is located in an industrial / commercial area in the City of Gonzales along the westerly side of Alta Street between Foleta and 10th Streets in an existing franchise. The new poles will maintain the same height, with the exception of two that will be raised approximately 5 feet taller than the existing poles to ensure compliance with the CPUC's General Order 95 clearance requirements. Construction is expected to begin in fall 2008, or as soon possible thereafter, and to be completed by March of 2009 or as soon as possible thereafter.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption(s):

- The replacement of existing power line facilities or supporting structures with equivalent facilities or structure.
- Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.

Within 30 days after Pacific Gas and Electric Company has submitted its response, the Executive Director of the CPUC will send you a copy of an Executive Resolution granting or denying the request and stating the reasons for the decision.
