Power Line, County of Fresno**

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

The Company has been requested by the County of Fresno (County) to relocate a 330-foot long segment of the existing McCall-Reedley 115 kilovolt (kV) Power Line to accommodate the County's Academy Avenue Road widening project. An existing 100-foot tall wood pole located west of Academy Avenue approximately 1,300 feet north of Parlier Avenue is being replaced with a new 100-foot tall steel pole (replacement of existing facilities) approximately 48 feet westerly of the existing wood pole (minor relocation). In order to return the line to the existing alignment, the Company will interset an 80-foot tall steel pole (intersetting of additional support structure) approximately 97 feet southwesterly from the new 100-foot steel pole within the Company's existing alignment (existing easement). To support the 80-foot tall pole, the Company will also install a new 35-foot tall self-supporting steel strain pole and supporting guy wires within the Company's existing alignment (existing easement). The strain pole will be located approximately 50 feet northeasterly from the 80 foot tall pole. Work is scheduled to begin in November 2008, or as soon thereafter as possible, and will be completed by May 2009, or as soon thereafter as possible.

CPUC General Order 131-D, Section III, Subsection B.1. exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption(s),

- b) the replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- c) the minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.
- g) power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Proposed Project: Pacific Gas and Electric Company (PG&E) has been requested by the County of Fresno (County) to relocate a 330-foot long segment of the existing McCall-Reedley 115 kilovolt (kV) Power Line to accommodate the County's Academy Avenue Road widening project. An existing 100-foot tall wood pole located west of Academy Avenue approximately 1,300 feet north of Parlier Avenue is being replaced with a new 100-foot tall steel pole (replacement of existing facilities) approximately 48 feet westerly of the existing wood pole (minor relocation). Pacific Gas and Electric Company believes this project qualifies for the following exemption(s):

- b) the replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- c) the minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.
- g) power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

- 1. Your name, mailing address and daytime telephone number.
- 2. Reference to the CPUC Advice Letter Number and Project Name.
- 3. A clear description of the reason for the protest.
- 4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
