Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

**Purpose**

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

**Background**

Pacific Gas and Electric Company proposes to relocate an existing 115kV power line tower in Placer County on the west side of Highway 65 between the City of Wheatland and the City of Lincoln. This project is being done at the request of the California Department of Transportation to accommodate their Lincoln Bypass Project for the realignment of Highway 65. The existing tower is approximately 82 feet tall and is located along Highway 65 approximately 2900 feet northwest of the intersection of Riosa Road and Hwy 65. It will be relocated (minor relocation) and replaced by a tubular steel pole approximately 115 feet tall, which will be constructed along the existing alignment (existing franchise) approximately 162 feet southwest of the current location. The taller structure is needed to maintain proper ground clearance over the longer highway span. Construction is scheduled to begin in January 2009 or as soon as possible thereafter, and the new facility is planned to be in operation in October 2009 or as soon as possible after project completion.

CPUC General Order 131-D, Section III, Subsection B.1.c and g exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption(s):

- c. the minor relocation of existing power line facilities up to 2000 feet in length, or the intersetting of additional support structures between existing support structures.
- g. power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

### **Protests**

## NOTICE OF PROPOSED CONSTRUCTION

**PROJECT NAME:** Drum–Rio Oso 115kV Power Line Tower 38/275 Relocation, County of Placer  
**ADVICE LETTER NUMBER:** 3366-E

**Proposed Project:** Pacific Gas and Electric Company proposes to relocate an existing 115kV power line tower in Placer County on the west side of Highway 65 between the City of Wheatland and the City of Lincoln. This project is being done at the request of the California Department of Transportation to accommodate their Lincoln Bypass Project for the realignment of Highway 65. The existing tower is approximately 82 feet tall and is located along Highway 65 approximately 2900 feet northwest of the intersection of Riosa Road and Hwy 65. It will be relocated (minor relocation) and replaced by a tubular steel pole approximately 115 feet tall, which will be constructed along the existing alignment (existing franchise) approximately 162 feet southwest of the current location. The taller structure is needed to maintain proper ground clearance over the longer highway span. Construction is scheduled to begin in January 2009 or as soon as possible thereafter, and the new facility is planned to be in operation in October 2009 or as soon as possible after project completion.

**Exemption from CPUC Permit Requirement:** CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption(s):

- c. the minor relocation of existing power line facilities up to 2000 feet in length, or the intersetting of additional support structures between existing support structures.
- g. power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

**Public Review Process:** Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
