131-D, for the Table Mountain-Pease 60kV Power Line
Relocation, County of Butte**

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

In order to accommodate a Caltrans highway roadway widening project (Butte 99 Roadway Rehabilitation Project between Rio Bonito Road and Highway 162/Richvale East Road in Butte County), the Company must relocate approximately 98 wood power poles along approximately 4.75 miles of the existing Table Mountain-Pease 60kV Power Line (power line relocation which has undergone environmental review as part of a larger project). The project section of power line is located in an almost exclusively agricultural area just northeast of the community of Biggs and immediately west of the Thermalito Afterbay, but a few rural residences are located in proximity to the alignment. The wood poles to be relocated will be replaced with wood poles of the same height or up to 25 feet taller than the existing poles; of the poles to be relocated, approximately 6 will be up to 25 feet taller than existing, 37 will be up to 10 feet

taller than existing, and 55 will be the same height as existing. The new pole height increases are required to provide necessary line clearance at various new highway crossings, keep required separation to secondary circuits on the line, and to mitigate potential EMF at three locations. The relocation will occur immediately adjacent to the existing power line alignment or across the highway for sections of the alignment; all new poles will be located within the highway franchise area or road-widening set-back easement (existing easement). Construction is scheduled to begin in January 2009, or as soon as possible thereafter, with work expected to be completed by August 2009, or as soon as possible after project initiation.

CPUC General Order 131-D, Section III, Subsections B.1.f and B.1.g, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption(s):

- f. Power lines or substations to be relocated or constructed which have undergone environmental review pursuant to CEQA as part of a larger project, and for which the final CEQA document (Environmental Impact Report (EIR) or Negative Declaration) finds no significant unavoidable environmental impacts caused by the proposed line or substation.

The Department of Transportation (Caltrans) and the Federal Highway Administration have adopted a Mitigated Negative Declaration for the Butte 99 Roadway Rehabilitation Project, finding no significant unavoidable environmental impacts resulting from PG&E's proposed facilities. State Clearinghouse #2005102120, adopted January 23, 2006.

- g. Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Additionally, G.O. 131-D requires utilities to employ "no cost" and specified "low cost" measures to reduce public exposure to the electric and magnetic fields (EMFs) in accordance with CPUC Decision 06-01-042 and the "EMF Guidelines for Electric Facilities". The following measures are proposed for this project:

- PG&E proposes to raise the height of the new poles ten feet taller than the existing poles in the residential land use areas.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Electric and Magnetic Fields (EMF): Pacific Gas and Electric Company employs "no cost" and specified "low cost" measures to reduce public exposure to EMF in accordance with California Public Utilities Commission (CPUC) Decision 06-01-042 and Pacific Gas and Electric Company's "EMF Design Guidelines for Electrical Facilities." The following measures are proposed for this project:

- PG&E proposes to raise the height of the new poles ten feet taller than the existing poles in the residential land use areas.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III.B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemptions:

- f. Power lines or substations to be relocated or constructed which have undergone environmental review pursuant to CEQA as part of a larger project, and for which the final CEQA document (Environmental Impact Report (EIR) or Negative Declaration) finds no significant unavoidable environmental impacts caused by the proposed line or substation.

The Department of Transportation (Caltrans) and the Federal Highway Administration have adopted a Mitigated Negative Declaration for the Butte 99 Roadway Rehabilitation Project, finding no significant unavoidable environmental impacts resulting from PG&E's proposed facilities. (State Clearinghouse #2005102120, adopted January 23, 2006)

- g. Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.

Within 30 days after Pacific Gas and Electric Company has submitted its response, the Executive Director of the CPUC will send you a copy of an Executive Resolution granting or denying the request and stating the reasons for the decision.
