Subject: Submits Notice of Construction, Pursuant to General Order 131-D, for the Replacement of Approximately 34 Wood Power Poles in the Merced #1 70kV Power Line - County of Madera

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

In order to accommodate the replacement of 12 Kilovolt (12kV) distribution wires attached to poles below the Merced #1 70 Kilovolt (70kV) power line in the County of Madera, the Company will be replacing approximately 34 wood power poles (replacement of existing facilities) in the existing Merced #1 70kV power line. The replacement of the 12kV distribution wires is needed to continue to provide for the increasing electrical demand and to improve reliability in the northerly portions of Madera County. The line is located in a rural agricultural area along the easterly side of Road 4 (existing franchise) in Madera County, starting at a point where the power line crosses (from the westerly side to the easterly side of) Road 4 approximately 1 mile southerly of State Highway 152 and extending southerly along the easterly side of Road 4 approximately 2 miles to the Avenue 20 alignment. In order to maintain legal ground clearances, the poles will be increased approximately 5 feet in height (most existing poles are approximately 55 feet tall), and the two most northerly 55-foot tall wood poles (one on the westerly side and the other on the easterly side of Road 4) will be raised approximately 15 feet in height to accommodate the framing required for the power line to cross Road 4. Work is scheduled to begin in February 2009, or as soon thereafter as possible, and will be completed by May 2009, or as soon thereafter as possible.

CPUC General Order 131-D, Section III, Subsection B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemptions:

- b) The replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- g) Power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

NOTICE OF PROPOSED CONSTRUCTION

PROJECT NAME: Merced #1 70kV – Distribution Reconductor Project, County of Madera
ADVICE LETTER NUMBER: 3396-E

Proposed Project: In order to accommodate the replacement of 12 Kilovolt (12kV) distribution wires attached to poles below the Merced #1 70 Kilovolt (70kV) power line in the County of Madera, Pacific Gas and Electric Company (PG&E) will be replacing approximately 34 wood power poles (replacement of existing facilities) in the existing Merced #1 70kV power line. The replacement of the 12kV distribution wires is needed to continue to provide for the increasing electrical demand and to improve reliability in the northerly portions of Madera County. The line is located in a rural agricultural area along the easterly side of Road 4 (existing franchise) in Madera County, starting at a point where the power line crosses (from the westerly side to the easterly side of) Road 4 approximately 1 mile southerly of State Highway 152 and extending southerly along the easterly side of Road 4 approximately 2 miles to the Avenue 20 alignment. In order to maintain legal ground clearances, the poles will be increased approximately 5 feet in height (most existing poles are approximately 55 feet tall), and the two most northerly 55-foot tall wood poles (one on the westerly side and the other on the easterly side of Road 4) will be raised approximately 15 feet in height to accommodate the framing required for the power line to cross Road 4. Work is scheduled to begin in February 2009, or as soon thereafter as possible, and will be completed by May 2009, or as soon thereafter as possible.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III. B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemptions:

- b) The replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- g) Power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

- 1. Your name, mailing address and daytime telephone number.
- 2. Reference to the CPUC Advice Letter Number and Project Name.
- 3. A clear description of the reason for the protest.
- 4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
