Subject: Submits Notice of Construction, Pursuant to General Order 131-D, for the Stagg-Hammer 60kV Relocation in the City of Stockton, County of San Joaquin

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

In order to accommodate the City of Stockton's road widening project at Hammer Lane between Thornton Road and Alexandria Place in the City of Stockton, PG&E has been requested by the City of Stockton to relocate approximately 3,025 feet of the existing Stagg-Hammer 60kV power line that parallels Hammer Lane in the City of Stockton. PG&E will relocate the line from its present location on the south side of Hammer Lane to a new location approximately 15 feet to the south of the present location on Hammer Lane (existing franchise) between Thornton Road and Alexandria Place. Four 65-foot tall wood poles will be replaced with wood poles of similar height and approximately 5 wood poles will be replaced with taller wood poles. Three of the poles, which currently range from approximately 60 to 65 feet tall, will be replaced with approximately 5- to 10-foot taller wood poles, one 65-foot tall wood pole will be replaced with an approximately 13-foot taller wood pole, and one 65-foot tall wood pole will be replaced with an approximately 22-foot taller wood pole to provide adequate line clearance over proposed signal lights. Construction is scheduled to begin in March 2009 or as soon thereafter as possible, with completion in approximately four weeks or as soon as possible after construction begins.

CPUC General Order 131-D, Section III, Subsection B.1.g, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption(s),

"Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts."

Additionally, G.O. 131-D requires utilities to employ "no cost" and specified "low cost" measures to reduce public exposure to electric and magnetic fields (EMFs) in accordance with CPUC Decision 06-01-042 and the "EMF Guidelines for Electrical Facilities." The following measures are proposed for this project:

- Because there are no EMF mitigation measures available on this project that would meet the CPUC's benchmark of 4% or less of the total project cost, no "no cost" or "low-cost" measures will be employed.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

PROJECT NAME: STAGG-HAMMER 60KV RELOCATION (CITY OF STOCKTON)

Proposed Project: In order to accommodate the City of Stockton's road widening project at Hammer Lane between Thornton Road and Alexandria Place in the City of Stockton, PG&E has been requested by the City of Stockton to relocate approximately 3,025 feet of the existing Stagg-Hammer 60kV power line that parallels Hammer Lane in the City of Stockton. PG&E will relocate the line from its present location on the south side of Hammer Lane to a new location approximately 15 feet to the south of the present location on Hammer Lane (existing franchise) between Thornton Road and Alexandria Place. Four 65-foot tall wood poles will be replaced with wood poles of similar height and approximately 5 wood poles will be replaced with taller wood poles. Three of the poles, which currently range from approximately 60 to 65 feet tall, will be replaced with approximately 5- to 10-foot taller wood poles, one 65-foot tall wood pole will be replaced with an approximately 13-foot taller wood pole, and one 65-foot tall wood pole will be replaced with an approximately 22-foot taller wood pole to provide adequate line clearance over proposed signal lights. Construction is scheduled to begin in March 2009 or as soon thereafter as possible, with completion in approximately four weeks or as soon as possible after construction begins.

Electric and Magnetic Fields (EMF): Pacific Gas and Electric Company will employ "no cost" and specified "low cost" measures to reduce public exposure to EMF in accordance with California Public Utilities Commission (CPUC) Decision 06-01-042 and Pacific Gas and Electric Company's "EMF Design Guidelines for Electrical Facilities." The following measures are proposed for this project:

- Because there are no EMF mitigation measures available on this project that would meet the CPUC's benchmark of 4% or less of the total project cost, no "no cost" or "low cost" measures will be employed.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption:

- Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.

Within 30 days after Pacific Gas and Electric Company has submitted its response, the Executive Director of the CPUC will send you a copy of an Executive Resolution granting or denying the request and stating the reasons for the decision.
