Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

Pacific Gas and Electric Company (PG&E) has been requested by California Department of Transportation (Caltrans) to relocate a 5,200-foot segment of the Willow Pass – Contra Costa 60 kV power line parallel to Highway 4 in the City of Pittsburg in order to accommodate the widening of Highway 4 from Loveridge Road to Highway 160 (part of a larger project). The segment of line in conflict with the Caltrans widening project is located between Loveridge Road and Century Boulevard. In order to relocate the transmission line, 13 lattice steel poles will be replaced with 14 tubular steel poles. The new poles will be relocated to the north by approximately 40 feet in order to accommodate the road-widening project. The new poles will be approximately 5 to 20 feet taller than the existing poles to comply with the California Public Utility Commission's General Order 95, and two poles on either side of Loveridge Road will be raised by approximately 40 feet in order to accommodate the proposed Loveridge Road and Highway 4 interchange. Construction is expected to begin in September 2009, or as soon as possible thereafter, and be completed by December 2010, or as soon as possible thereafter.

CPUC General Order 131-D, Section III, Subsection B.1.f, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption(s),

“Power lines or substations to be relocated or constructed which have undergone environmental review pursuant to CEQA as part of a larger project, and for which the final CEQA document (Environmental Impact Report (EIR) or Negative Declaration) finds no significant unavoidable environmental impacts caused by the proposed line or substation.”

Caltrans has adopted a Negative Declaration for the widening of Highway 4 from Loveridge Road to Highway 160, finding no significant unavoidable environmental impacts resulting from the relocation of PG&E’s facilities (State Clearinghouse #2004092135).

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

Anyone wishing to protest this filing may do so by filing a protest with the CPUC and the Company by **July 6, 2009**, which is 20 days after the date of this filing. Protests should be mailed to the following address:

NOTICE OF PROPOSED CONSTRUCTION

PROJECT NAME: WILLOW PASS – CONTRA COSTA 60 KV RELOCATION, CITY OF PITTSBURG
ADVICE LETTER NUMBER: 3478-E

Proposed Project: Pacific Gas and Electric Company (PG&E) has been requested by California Department of Transportation (Caltrans) to relocate a 5,200-foot segment of the Willow Pass – Contra Costa 60 kV power line parallel to Highway 4 in the City of Pittsburg in order to accommodate the widening of Highway 4 from Loveridge Road to Highway 160 (part of a larger project). The segment of line in conflict with the Caltrans widening project is located between Loveridge Road and Century Boulevard. In order to relocate the transmission line, 13 lattice steel poles will be replaced with 14 tubular steel poles. The new poles will be relocated to the north by approximately 40 feet in order to accommodate the road-widening project. The new poles will be approximately 5 to 20 feet taller than the existing poles to comply with the California Public Utility Commission's General Order 95, and two poles on either side of Loveridge Road will be raised by approximately 40 feet in order to accommodate the proposed Loveridge Road and Highway 4 interchange. Construction is expected to begin in September 2009, or as soon as possible thereafter, and be completed by December 2010, or as soon as possible thereafter.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III.B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption:

- Power lines or substations to be relocated or constructed which have undergone environmental review pursuant to CEQA as part of a larger project, and for which the final CEQA document (Environmental Impact Report (EIR) or Negative Declaration) finds no significant unavoidable environmental impacts caused by the proposed line or substation.

Caltrans has adopted a Negative Declaration for the widening of Highway 4 from Loveridge Road to Highway 160, finding no significant unavoidable environmental impacts resulting from the relocation of PG&E's facilities. (State Clearinghouse #2004092135)

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist:

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
