Subject: Submits Notice of Construction, Pursuant to General Order 131-D, for the Construction of Rio Bravo-Kern Oil 115kV Power Line Relocation Project, City of Shafter, County of Kern

Pacific Gas and Electric Company (PG&E) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

The City of Shafter has requested that PG&E relocate approximately 1900 feet of the existing Rio Bravo-Kern Oil 115 kilovolt power line (minor relocation) to allow for a grade separation project at the intersection of Seventh Standard Road and the Burlington Northern & Santa Fe Railway approximately six miles southeast from the city center of the City of Shafter. The relocation will require PG&E to remove three existing lattice steel poles approximately 75 feet tall and two existing wood poles approximately 65 feet tall along the south side of Seventh Standard Road. PG&E will then install approximately 9 new wood poles approximately 75 feet tall, six on the north side and three on the south side of Seventh Standard Road (existing franchise). Construction is tentatively scheduled to begin in November 2009, or as soon thereafter as possible, and is scheduled for completion in December 2009, or as soon thereafter as possible.

CPUC General Order 131-D, Section III, Subsection B.1.x, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. PG&E believes this project qualifies for the following exemption(s):

c. the minor relocation of existing power line facilities up to 2000 feet in length, or the intersetting of additional support structures between existing support structures.

g. power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

Anyone wishing to protest this filing may do so by filing a protest with the CPUC and PG&E by **September 7, 2009**, which is 20 days after the date of this filing. Protests should be mailed to the following address:



NOTICE OF PROPOSED CONSTRUCTION

PROJECT NAME: Rio Bravo-Kern Oil 115kV Power Line Relocation Project, City of Shafter & County of Kern
ADVICE LETTER NUMBER: 3509-E

Proposed Project: The City of Shafter has requested that Pacific Gas and Electric Company (PG&E) relocate approximately 1900 feet of the existing Rio Bravo-Kern Oil 115 kilovolt power line (minor relocation) to allow for a grade separation project at the intersection of Seventh Standard Road and the Burlington Northern & Santa Fe Railway approximately 6 miles southeast from the city center of the City of Shafter. The relocation will require PG&E to remove three existing lattice steel poles approximately 75 feet tall and two existing wood poles approximately 65 feet tall along the south side of Seventh Standard Road. PG&E will then install approximately 9 new wood poles approximately 75 feet tall, six on the north side and three on the south side of Seventh Standard Road (existing franchise). Construction is tentatively scheduled to begin in November 2009, or as soon thereafter as possible, and is scheduled for completion in December 2009, or as soon thereafter as possible.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption(s):

- c. the minor relocation of existing power line facilities up to 2000 feet in length, or the intersetting of additional support structures between existing support structures.
- g. power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

- 1. Your name, mailing address and daytime telephone number.
- 2. Reference to the CPUC Advice Letter Number and Project Name.
- 3. A clear description of the reason for the protest.
- 4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.

Within 30 days after Pacific Gas and Electric Company has submitted its response, the Executive Director of the CPUC will send you a copy of an Executive Resolution granting or denying the request and stating the reasons for the decision.
