In accordance with the provisions of General Order 96-B, Section 5.3, PG&E is withdrawing Advice 3045-G-/3522-E, which was filed with the Commission on September 11, 2009. This filing requested authorization to utilize unspent and uncommitted Self Generation Incentive Program (SGIP) funds to augment the funding available through the Relief for Energy Assistance through Community Help (REACH) Program to customers in need.

In discussions with the Division of Ratepayers Advocates, PG&E agreed to withdraw this advice letter contingent upon approval of Advice 3622-E/3097-G, *Request to Use CARE Funds to Supplement PG&E's Relief for Energy Assistance through Community Help (REACH) Program*.

Therefore, PG&E withdraws Advice 3045-G/3522-E from further consideration for approval by the Commission.

Subject: Request to Increase Funding for PG&E's Relief for Energy Assistance through Community Help (REACH) Program

Pacific Gas and Electric Company (PG&E) hereby requests authorization to utilize unspent and uncommitted Self Generation Incentive Program (SGIP) funds to augment the funding available through the Relief for Energy Assistance through Community Help (REACH) Program to customers in need. PG&E's proposal follows the model recently approved by the Commission in Resolution E-4251, dated September 10, 2009, on similar requests by San Diego Gas and Electric (SDG&E) and Southern California Gas (SoCalGas) to use a matching ratepayer contribution to increase the funding for their respective charitable Neighbor-to-Neighbor and Gas Assistance Fund programs (ref. SDG&E Advice Letter 2065-E/1842-G and SoCalGas Advice Letter 3963-G). Since these funds have already been recovered from customers, this request will not result in a rate increase.

Purpose

The purpose of this filing is to request California Public Utilities Commission (Commission) authorization to transfer up to \$7 million from the SGIP budget over 2009 and 2010. These funds will be leveraged to the extent possible with the Temporary Assistance for Needy Families (TANF) Program that allows for a four-to-one match which will make available additional funds for the REACH Program. REACH is a one-time energy-assistance program sponsored by PG&E which is administered through The Salvation Army from its 170 offices in northern and central California. Through REACH, eligible low-income customers who have experienced an uncontrollable or unforeseen hardship may receive an energy credit on their utility bill. The size and frequency of the energy credit amount is based upon a number of criteria, but its availability depends upon funding. At the level of funding being proposed, many of PG&E's low-income customers would be able to take full advantage of the additional funding that would be available to California under the American Recovery and Reinvestment Act (Recovery Act) of 2009.

Background

Unemployment in California is now reaching levels approaching 12%¹ and the levels of foreclosures are unparalleled. Under the current economic conditions, PG&E has been experiencing an increase in the number of calls from customers requesting bill payment assistance. With companies downsizing and families losing their homes, many of PG&E's gas and electric customers are experiencing difficulties paying their gas and electric bills.

The severity of the economic crisis is further evidenced by the magnitude of the federal government's stimulus package developed by Congress. Under the American Recovery and Reinvestment Act (Recovery Act), up to \$5 billion was appropriated for the TANF Emergency Contingency Fund (known as the Emergency Fund) over fiscal years 2009 and 2010. This Emergency Fund is in addition to the regular TANF Contingency Fund that needy families in California can access through established agencies during the economic downturn. Additional information on the Emergency Fund is available on the Department of Health and Human Services website at: www.hhs.gov/recovery/reports/plans/tanf_emergencyfund.pdf.

In an effort to respond expeditiously to customers' concerns in this economic climate and to take advantage of the availability of additional monies through the Emergency Fund, PG&E is seeking authorization to expand the level of funding for its REACH program. As previously noted, REACH is a one-time energy-assistance program sponsored by PG&E which is administered through The Salvation Army from its 170 offices in northern and central California. Through REACH, eligible low-income customers who have experienced an uncontrollable or unforeseen hardship may receive an energy credit on their utility bill. The size and frequency of the energy credit amount is based upon a number of criteria, but its availability depends upon funding. Since the REACH program was initiated in 1983, the primary² source of funding has been through the generous contributions of PG&E, its customers, employees and retirees.

In 2009 and 2010, PG&E's charitable corporation foundation will be asked to contribute over \$1 million to REACH for programmatic assistance. Based upon the funding model adopted for SDG&E and SoCalGas in Commission Resolution E-4251, PG&E is proposing that the amounts it contributes in 2009 and 2010 be

matched with ratepayer funding on up to a five-to-one basis.³ To that end, PG&E proposes to transfer up to \$7 million in unspent and uncommitted SGIP funds over the same two year period to augment the funding available to REACH participants and cover incremental administrative expenses. The SGIP budget currently resides in two balancing accounts, the Electric Self Generation Program Memorandum Account (ref. Preliminary Statement BY) and the Gas Self Generation Program Memorandum Account (ref. Preliminary Statement AW). The funds transferred will be allocated between commodities in accordance with the respective electric and gas SGIP allocation factors of eighty-three percent (83%) and seventeen percent (17%),⁴ and recorded in a newly created REACH account. These additional funds would be administered by The Salvation Army, in a manner consistent with the REACH program. It is also PG&E's intent to have The Salvation Army use the money contributed by shareholders prior to utilizing any transferred balances. Any unused funds remaining at the conclusion of the current allocation to the Emergency Fund (currently projected to end on September 30, 2010) will be retained to assist low-income customers through our existing REACH program. Since PG&E will be using the existing SGIP budget as a source of funding for the matching ratepayer contribution, the transfer of funds will not result in an increase in overall rates.

PG&E recognizes that not all customers seeking assistance through the REACH program will also qualify for additional assistance through TANF, but we expect that a significant number will be able to qualify. With the four-to-one match being made available through the Emergency Fund, approval of up to \$7 million in additional REACH funding coupled with other contributions will result in a significant increase in the amount of funds that are available to customers in need. Given the downturn in the economy and the resulting impact on low-income customers, the additional funding made available through a combination of REACH and the Emergency Fund will provide much needed relief to customers who are experiencing extreme financial hardship.

The REACH Program is one of several assistance programs that PG&E provides its customers. PG&E will continue to offer and communicate its currently existing services such as the California Rates for Energy (CARE) program, Family Rate Electric Assistance (FERA) program, Medical Baseline program, Low Income Energy Efficiency (LIEE) program and Balanced Payment Plans. PG&E also informs customers that they may also be able to receive bill and home weatherization assistance through the California Department for Community Services and Development's Low Income Home Energy Assistance Program.

Taken as a whole, these programs provide PG&E customers with several resources for assistance.

In accordance with Resolution E-4251, PG&E intends to give appropriate credit to the ratepayers' funding in all its marketing and promotion materials related to the REACH program.⁵

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any rate schedule or rule.

Program Results

To keep the Commission apprised of the distribution of funds through the REACH program, PG&E proposes to file a separate report alongside our 2010 and 2011 CARE/LIEE annual reports with the following information:

1. REACH payment assistance provided to customers separated by shareholder funded and ratepayer funded distributions
2. Remaining funds from previously authorized ratepayer contributions to be carried into subsequent fiscal years.
3. A breakdown of funds segregated between administrative and direct assistance expenditures.
4. A breakdown of distributed funds between CARE and non-CARE recipients.

Protest Period

Anyone wishing to protest this filing may do so by sending a letter by **October 1, 2009**, which is 20 days from the date of this filing. The protest must state the grounds upon which it is based, including such items as financial and service impact, and should be should mailed to:
