**Subject: Submits Notice of Construction, Pursuant to General Order 131-D,
for the Lincoln 1103 12 kV Relocation Project, County of Placer**

Pacific Gas and Electric Company ("PG&E" or "Company") hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

Caltrans is currently constructing its Route 65 Lincoln Bypass Project at Wise Road between Dowd Road and Highway 65 in Placer County, and has requested PG&E to relocate approximately 3,581 feet of the existing Lincoln 1103 12 kV power line that parallels Wise Road in this location. PG&E will relocate the line from its present location on the south side of Wise Road into an existing public utility easement (existing easement) approximately 50 to 300 feet to the north of the present location on Wise Road between Dowd Road and Highway 65. In order to accommodate a future 115 kV power line project planned between Lincoln and Rio Oso substations, the relocated line will be constructed to hold both 115 kV and 12 kV lines. To accomplish this, and to ensure legal ground to conductor clearance for the proposed highway crossing, 15 wood poles that are 35 to 40 feet tall will be replaced with eight approximately 32 to 37 feet taller wood poles and six approximately 40 to 45 feet taller tubular steel poles (TSP). Construction is scheduled to begin in December 2009 or as soon thereafter as possible, with completion in approximately four weeks or as soon as possible after construction begins.

CPUC General Order 131-D, Section III, Subsection B.1.g, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting

authority to construct. The Company believes this project qualifies for the following exemption(s):

- “Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.”

Additionally, G.O. 131-D requires utilities to employ "no cost" and specified "low cost" measures to reduce public exposure to electric and magnetic fields (EMFs) in accordance with CPUC Decision 06-01-042 and the “EMF Guidelines for Electrical Facilities.” The following measures are proposed for this project:

- Because there are no EMF mitigation measures available on this project that would meet the CPUC’s benchmark of 4% or less of the total project cost, no “no cost” or “low-cost” measures will be employed.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

Proposed Project: Caltrans is currently constructing its Route 65 Lincoln Bypass Project at Wise Road between Dowd Road and Highway 65 in Placer County, and has requested PG&E to relocate approximately 3,581 feet of the existing Lincoln 1103 12 kV power line that parallels Wise Road in this location. PG&E will relocate the line from its present location on the south side of Wise Road into an existing public utility easement (existing easement) approximately 50 to 300 feet to the north of the present location on Wise Road between Dowd Road and Highway 65. In order to accommodate a future 115 kV power line project planned between Lincoln and Rio Oso substations, the relocated line will be constructed to hold both 115 kV and 12 kV lines. To accomplish this, and to ensure legal ground to conductor clearance for the proposed highway crossing, 15 wood poles that are 35 to 40 feet tall will be replaced with eight approximately 32 to 37 feet taller wood poles and six approximately 40 to 45 feet taller tubular steel poles (TSP). Construction is scheduled to begin in December 2009 or as soon thereafter as possible, with completion in approximately four weeks or as soon as possible after construction begins.

Electric and Magnetic Fields (EMF): Pacific Gas and Electric Company will employ "no cost" and specified "low cost" measures to reduce public exposure to EMF in accordance with California Public Utilities Commission (CPUC) Decision 06-01-042 and Pacific Gas and Electric Company's "EMF Design Guidelines for Electrical Facilities." The following measures are proposed for this project:

- Because there are no EMF mitigation measures available on this project that would meet the CPUC's benchmark of 4% or less of the total project cost, no "no cost" or "low cost" measures will be employed.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III.B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption:

- Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
