Re: Withdrawal of Advice 3561-E/3061-G

Dear Ms. Fitch:

In accordance with the provisions of General Order 96-B, Section 5.3, PG&E is withdrawing Advice 3561-E-/3061-G, which was filed with the Commission on November 19, 2009. This filing proposed a request for approval to transfer electric carryover funding from the Electric Public Purpose Programs Low Income Balancing Account (PPPLIBA) to the Gas PPPLIBA balance so as to promote the efficient and effective implementation of the LIEE program and in order to maintain the 59% / 41% split as approved for the 2009-2011 LIEE program.

PG&E has reviewed DRA's protest and determined that it will not seek to transfer electric funds to the gas account at this time, but will rather apply the surplus electric funds to the installation of electric measures. There may be an adjustment required at a later date, but additional time will also allow PG&E to determine more precisely the appropriate level of split between gas and electric related measures for the 2009-2011 program cycle.

Therefore, PG&E withdraws Advice 3561-E-G/3061-G from further consideration for approval by the Commission.

Subject: Request for Approval to Transfer Electric Low Income Energy Efficiency (LIEE) Carryover Funds

Pacific Gas and Electric Company (PG&E) requests approval to transfer electric carryover funding from the Electric Public Purpose Programs Low Income Balancing Account (PPPLIBA) to the Gas PPPLIBA balance so as to promote the efficient and effective implementation of the LIEE program and in order to maintain the 59% / 41% split as approved for the 2009-2011 LIEE program.

Purpose

On November 6, 2008, the California Public Utilities Commission (Commission) approved Decision (D.) 08-11-031, *Decision on Large Investor Owned Utilities LIEE and California Alternate Rates for Energy (CARE) Applications*, in which Ordering Paragraph (OP) 85 authorizes the utilities "carry over of remaining, unspent funds from program year to program year or budget cycle to budget cycle: the utilities may carry over funds from previous periods to the 2009-2011 budget periods but may not allocate carry-over funds to administrative overheads, regulatory compliance costs, measurement and evaluation, or pilots and studies." OP 85 further states that "fund shifting between gas/electric programs: Tier 2 advice letter required."

Transfer of Electric Funds to Gas Program Budget

At the end of Program Year (PY) 2008, PG&E had an unspent electric budget of \$8,706,963, including interest, which it carried over to augment the PY 2009 electric budget, as authorized in D.08-11-031. There was a \$0 balance for the PY 2008 gas budget. The current expense ratio and budget allocation factors for PG&E's 2009-2011 LIEE program are 41% for gas and 59% for electric, as approved by the Commission in Advice Letter 2979-G/3375-E. PG&E proposes to transfer \$3,569,855 from the Electric PPPLIBA to the Gas PPPLIBA in order to maintain the 59% / 41% split as approved for the 2009-2011 LIEE program. The

carryover funds will be used towards gas and electric measures as authorized by D.08-11-031.
