Pacific Gas and Electric Company ("PG&E" or "the Company") hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

In order to accommodate improvements to Athens Avenue for the United Auburn Indian Community's Thunder Valley Expansion Project, PG&E has been requested by the Community to relocate approximately 347 feet (minor relocation) of the existing Lincoln-Pleasant Grove 60kV power line that parallels Athens Road in the County of Placer. PG&E will relocate the line from its present location on the south side of Athens Road to a new location approximately 9 feet to the south, still on the south side of Athens Road just west of Thunder Valley Court. One 50-foot tall wood pole will be replaced with an approximately 8-foot taller wood pole and one 55-foot tall wood pole will be replaced with an approximately 17-foot taller wood pole to provide adequate line clearance over proposed signal lights. The United Auburn Indian Community adopted a Tribal Environmental Impact Report for the Thunder Valley Expansion Project, finding no significant unavoidable environmental impacts resulting from PG&E's proposed relocation (State Clearinghouse #2007062072). Construction is scheduled to begin in February 2010 or as soon thereafter as possible, with

completion in approximately four weeks or as soon as possible after construction begins.

CPUC General Order 131-D, Section III, Subsection B.1., exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption:

- "The minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures."

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

Anyone wishing to protest this filing may do so by filing a protest with the CPUC and the Company by **January 20, 2010**, which is 20 days after the date of this filing. Protests should be mailed to the following address:

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III.B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption:

- The minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.

Within 30 days after Pacific Gas and Electric Company has submitted its response, the Executive Director of the CPUC will send you a copy of an Executive Resolution granting or denying the request and stating the reasons for the decision.
