Subject: Submits Notice of Construction, Pursuant to General Order 131-D, for the Construction of the Lockheed #2 115kV Tap Underbuild Project in the City of Sunnyvale, County of Santa Clara

Pacific Gas and Electric Company ("PG&E" or "the Company") hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

In order to provide safe and reliable electric service, PG&E will install a new electric distribution line on an approximately 1500-foot section of the existing Lockheed #2 115kV Tap pole line, located along E street, between 1st and 2nd Avenues, in the Lockheed Industrial Complex in Sunnyvale (existing easement). In order to maintain safe distances between wires, five wood power poles will be replaced with approximately fifteen-foot taller light-duty steel poles (replacement of existing facilities). Additionally, one light-duty steel pole will be added in order to maintain proper ground clearance (intersetting of additional support structures).

Construction is expected to begin in April 2010, or as soon as possible thereafter, and to be completed by May 2010, or as soon as possible thereafter.

CPUC General Order 131-D, Section III, Subsections B.1.b., B.1.c., and B.1.g. exempts projects meeting specific conditions from the CPUC's requirement to file

an application requesting authority to construct. The Company believes this project qualifies for the following exemptions:

- b) The replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- c) The minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.
- g) Power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

Anyone wishing to protest this filing may do so by filing a protest with the CPUC and the Company by **March 18, 2010**, which is 20 days after the date of this filing. Protests should be mailed to the following address:

Proposed Project: In order to provide safe and reliable electric service, Pacific Gas and Electric Company (PG&E) will install a new electric distribution line on an approximately 1500-foot section of the existing Lockheed #2 115kV Tap pole line, located along E street, between 1st and 2nd Avenues, in the Lockheed Industrial Complex in Sunnyvale (existing easement). Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III.B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemptions:

- The minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.
- Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.
- The replacement of existing power line facilities or supporting structures with equivalent facilities or structures.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
