Pacific Gas and Electric Company ("PG&E" or "the Company") hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

In order to continue to operate a reliable electric transmission system in the region, PG&E is proposing to replace the wood poles along an approximately 12-mile stretch of the existing Woodland-Davis 115kV pole line in the County of Yolo, cities of Davis and Woodland (replacement of existing power line facilities, existing easement or franchise). The line segment to be replaced runs between Woodland Substation, approximately one-quarter mile east of East Street and north of Main Street in the City of Woodland, to Davis Substation at "L" Street and 2nd Street in the City of Davis. The power line generally runs east from Woodland Substation for approximately two miles to County Road 102, then south along County Road 102 approximately one-half mile, then crosses the California Northern Railroad and Interstate 5, continues south along County Road 102 approximately eight miles to Covell Road, then south roughly one-quarter mile to Claremont Drive, then west approximately one-quarter mile, then south approximately one mile to Davis Substation. The project consists of replacing approximately 153 existing wood poles with new wood poles or light-duty steel (LDS) poles with a finish that weathers to resemble wood poles. The new poles will be up to 15 feet taller than the existing poles to comply with GO 95 crossing requirements over

Interstate 5 and the railroad. Construction is scheduled to begin in mid-2010, or as soon as possible thereafter, and the new facilities are planned to be in operation in December 2011, or as soon as possible after project completion.

CPUC General Order 131-D, Section III, Subsection B.1., exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption(s):

- The replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement, or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

NOTICE OF PROPOSED CONSTRUCTION

PROJECT NAME: WOODLAND-DAVIS 115kV POLE REPLACEMENT PROJECT, COUNTY OF YOLO, CITIES OF DAVIS AND WOODLAND

Proposed Project: In order to continue to operate a reliable electric transmission system in the region, Pacific Gas and Electric Company (PG&E) is proposing to replace the wood poles along an approximately 12-mile stretch of the existing Woodland-Davis 115kV pole line in the County of Yolo, cities of Davis and Woodland (replacement of existing power line facilities, existing easement or franchise). The line segment to be replaced runs between Woodland Substation, approximately one-quarter mile east of East Street and north of Main Street in the City of Woodland, to Davis Substation at "L" Street and 2nd Street in the City of Davis. The power line generally runs east from Woodland Substation for approximately two miles to County Road 102, then south along County Road 102 approximately one-half mile, then crosses the California Northern Railroad and Interstate 5, continues south along County Road 102 approximately eight miles to Covell Road, then south roughly one-quarter mile to Claremont Drive, then west approximately one-quarter mile, then south approximately one mile to Davis Substation. The project consists of replacing approximately 153 existing wood poles with new wood poles or light-duty steel (LDS) poles with a finish that weathers to resemble wood poles. The new poles will be up to 15 feet taller than the existing poles to comply with GO 95 crossing requirements over Interstate 5 and the railroad. Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III.B, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemptions:

- The replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement, or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may impact an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.

Within 30 days after Pacific Gas and Electric Company has submitted its response, the Executive Director of the CPUC will send you a copy of an Executive Resolution granting or denying the request and stating the reasons for the decision.
