Subject: Submits Notice of Construction, Pursuant to General Order 131-D, for the Construction of Pease – Rio Oso 115 kV Tower Replacement Project at Bear River in the Counties of Sutter and Yuba

Pacific Gas and Electric Company (“PG&E” or “the Company”) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

In order to provide safe and reliable electric service to customers in the Sacramento Valley, Pacific Gas and Electric Company (PG&E) is proposing to remove six deteriorated lattice steel transmission towers and replace them with five new tubular steel poles (replacement of existing facilities, existing easement). The existing towers are located approximately 2,000 feet east of Highway 70 and run parallel to the highway between Feather River Boulevard in Yuba County and Rio Oso Road in Sutter County. The new poles will be approximately 15 feet taller than the existing towers in order to provide the required clearances specified in General Order 95 and match the pole heights on the existing parallel transmission line. After the new poles are installed, approximately 3,500 feet of the existing deteriorated wires (conductors) will be replaced with new conductors (reconductor). The project has been scheduled and designed to avoid and minimize biological impacts to the Giant Garter Snake and the Valley Elderberry Longhorn Beetle (VELB). Additionally, it has been appended to the Fish and Wildlife Service’s November 13, 1997 “Programmatic Formal Consultation for Army Corps of Engineers 404 Permitted Projects With Relatively Small Effects on

the Giant Garter Snake within Butte, Colusa, Glenn, Fresno, Merced, Sacramento, San Joaquin, Solano, Stanislaus, Sutter and Yolo Counties,” and is covered by the June 23, 2003, Biological Opinion issued for PG&E’s VELB Conservation Program. Construction is expected to begin in August 2010, or as soon as possible thereafter, and be completed in December 2012, or as soon as possible thereafter.

CPUC General Order 131-D, Section III, Subsection B.1.b.g exempts projects meeting specific conditions from the CPUC’s requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemptions:

- b. The replacement of existing power line facilities or supporting structures with equivalent facilities or structures, and
- g. Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

Anyone wishing to protest this filing may do so by filing a protest with the CPUC and the Company by **July 29, 2010**, which is 20 days after the date of this filing. Protests should be mailed to the following address:

PROJECT NAME: Pease-Rio Oso 115 kV Tower Replacement Project at Bear River, Counties of Sutter and Yuba

ADVICE LETTER NUMBER: 3702-E

Proposed Project: In order to provide safe and reliable electric service to customers in the Sacramento Valley, Pacific Gas and Electric Company (PG&E) is proposing to remove six deteriorated lattice steel transmission towers and replace them with five new tubular steel poles (replacement of existing facilities, existing easement). The existing towers are located approximately 2,000 feet east of Highway 70 and run parallel to the highway between Feather River Boulevard in Yuba County and Rio Oso Road in Sutter County. Additionally, it has been appended to the Fish and Wildlife Service's November 13, 1997 "Programmatic Formal Consultation for Army Corps of Engineers 404 Permitted Projects With Relatively Small Effects on the Giant Garter Snake within Butte, Colusa, Glenn, Fresno, Merced, Sacramento, San Joaquin, Solano, Stanislaus, Sutter and Yolo Counties," and is covered by the June 23, 2003, Biological Opinion issued for PG&E's VELB Conservation Program. Construction is expected to begin in August 2010, or as soon as possible thereafter, and be completed in December 2012, or as soon as possible thereafter.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III.B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption:

- b. The replacement of existing power line facilities or supporting structures with equivalent facilities or structures
- g. Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

- 1. Your name, mailing address and daytime telephone number.
- 2. Reference to the CPUC Advice Letter Number and Project Name.
- 3. A clear description of the reason for the protest.
- 4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
