Pacific Gas and Electric Company ("PG&E" or "the Company") hereby submits notice pursuant to General Order ("G.O.") 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

To accommodate the road-widening of Santa Rosa Avenue in Santa Rosa by the City of Santa Rosa, PG&E must relocate approximately 1,652 feet (minor relocation) of the existing Santa Rosa-Corona 115 kilovolt (kV) Power Line. For this relocation (all in existing franchise), seven existing wood poles, each approximately 57 to 61 feet tall, will be replaced with eight wood poles, each approximately 70 to 78 feet tall, to allow for sufficient distance between the street lights and the lowest PG&E conductor (wire). This relocation will begin at an existing pole located in Santa Rosa Avenue approximately 355 feet south of the intersection of Santa Rosa Avenue and Yolanda Avenue, and extend north along the easterly boundary line of Santa Rosa Avenue approximately 1,652 feet to an existing pole located approximately 120 feet north of the intersection of Santa Rosa Avenue and Kawana Springs Road. Construction activities are tentatively scheduled to begin in April 2011, or as soon as possible thereafter, with the relocations scheduled to be operational in June 2011, or as soon as possible after construction is completed.

CPUC General Order 131-D, Section III, Subsection B.1., exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting

authority to construct. The Company believes this project qualifies for the following exemption(s):

- (c) The minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.
- (g) Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

Anyone wishing to protest this filing may do so by filing a protest with the CPUC and the Company by **February 24, 2011**, which is 20 days after the date of this filing. Protests should be mailed to the following address:

NOTICE OF PROPOSED CONSTRUCTION

PROJECT NAME: Santa Rosa-Corona 115kV Power Line Relocation, City of Santa Rosa
ADVICE LETTER NUMBER: 3802-E

Proposed Project: To accommodate the road-widening of Santa Rosa Avenue in Santa Rosa by the City of Santa Rosa, Pacific Gas and Electric Company (PG&E) must relocate approximately 1,652 feet (minor relocation) of the existing Santa Rosa-Corona 115 kilovolt (kV) Power Line. For this relocation (all in existing franchise), seven existing wood poles, each approximately 57 to 61 feet tall, will be replaced with eight wood poles, each approximately 70 to 78 feet tall, to allow for sufficient distance between the street lights and the lowest PG&E conductor (wire). This relocation will begin at an existing pole located in Santa Rosa Avenue approximately 355 feet south of the intersection of Santa Rosa Avenue and Yolanda Avenue, and extend north along the easterly boundary line of Santa Rosa Avenue approximately 1,652 feet to an existing pole located approximately 120 feet north of the intersection of Santa Rosa Avenue and Kawana Springs Road. Construction activities are tentatively scheduled to begin in April 2011, or as soon as possible thereafter, with the relocations scheduled to be operational in June 2011, or as soon as possible after construction is completed.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III.B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemptions:

- (c) The minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.
- (g) Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
