Subject: Submits Notice of Construction, Pursuant to General Order 131-D, for the Construction of Del Monte #1 & #2 60 kV Power Line in the City of Seaside, County of Monterey

Pacific Gas and Electric Company ("PG&E" or "the Company") hereby submits notice pursuant to General Order ("G.O.") 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

To support Fort Ord Reuse Authority in the rearrangement of Hilby Avenue and General Jim Moore Boulevard in the City of Seaside, PG&E has been requested to remove and relocate a single existing lattice steel tower with foundation, along the existing Del Monte #1 & #2 60 kV powerline at the northeast corner of Hilby Avenue and Mescal Street (minor relocation, existing easement), approximately 140 feet south, down slope of the existing location and in line with the existing line. The new lattice steel tower with foundation will be approximately 15 feet taller than the existing tower to comply with General Order 95 clearance requirements. PG&E's tower relocation will need to be completed before the proposed new streetlight is installed at the cross street of Hilby Avenue and General Jim Moore Boulevard, and will allow for increased public safety and access. Thus, Fort Ord Reuse Authority has requested that PG&E's relocation activities begin in June 2011 or as soon as possible thereafter for completion by September 2011 or as soon as possible thereafter.

CPUC General Order 131-D, Section III, Subsection B.1., exempts projects meeting specific conditions from the CPUC's requirement to file an application

requesting authority to construct. The Company believes this project qualifies for the following exemptions:

- (c.) The minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.
- (g.) Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Proposed Project: To support Fort Ord Reuse Authority in the rearrangement of Hilby Avenue and General Jim Moore Boulevard in the City of Seaside, Pacific Gas & Electric Company (PG&E) has been requested to remove and relocate a single existing lattice steel tower with foundation, along the existing Del Monte #1 & #2 60 kV powerline at the northeast corner of Hilby Avenue and Mescal Street (minor relocation, existing easement), approximately 140 feet south, down slope of the existing location and in line with the existing line. The new lattice steel tower with foundation will be approximately 15 feet taller than the existing tower to comply with General Order 95 clearance requirements. PG&E's tower relocation will need to be completed before the proposed new streetlight is installed at the cross street of Hilby Avenue and General Jim Moore Boulevard, and will allow for increased public safety and access. Thus, Fort Ord Reuse Authority has requested that PG&E's relocation activities begin in June 2011 or as soon as possible thereafter for completion by September 2011 or as soon as possible thereafter.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemptions:

- (c.) the minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.
- (g.) power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.

Within 30 days after Pacific Gas and Electric Company has submitted its response, the Executive Director of the CPUC will send you a copy of an Executive Resolution granting or denying the request and stating the reasons for the decision.
