Subject: Supplemental Filing - Submits Notice of Construction, Pursuant to General Order 131-D, for the Construction Laytonville-Garberville 60 Kilovolt Pole Replacement Project in the County of Mendocino

Pacific Gas and Electric Company ("PG&E" or "the Company") hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

This advice letter supersedes Advice 3867-E in its entirety.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

In order to continue to operate a reliable electric transmission system in the region, PG&E is proposing to replace 17 poles (replacement of existing facilities) along the Garberville-Laytonville 60 kV Power Line (existing easement) in Mendocino County as part of required maintenance to maintain service reliability. The proposed project will remove approximately 16 existing wooden transmission poles and one distribution pole (part of the 12kV underbuild that is present along this portion of the 60 kV line) and replace them with light-duty steel poles, which will weather to resemble wood. The poles will be replaced along an approximately 1.5-mile power line segment that runs north/south to the west of Bell Springs Road, approximately 18 miles southeast of the town of Garberville west of Bell Springs Road. In order to meet California Public Utilities Commission (CPUC) General Order 95 minimum ground-to-conductor clearance requirements and current design standards, 15 of the 17 new poles will be approximately 5 to 15 feet taller and two poles will remain the same height. Poles will generally be

replaced adjacent to the existing pole locations, within the current easement. Work is scheduled to begin in September 2011 and to be completed in November 2011, or as soon thereafter as weather conditions, permitting and construction issues allow.

CPUC General Order 131-D, Section III, Subsection B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption(s):

- The replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- "Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement, or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

Anyone wishing to protest this filing may do so by filing a protest with the CPUC and the Company by **August 31, 2011**, which is 20 days after the date of this filing. Protests should be mailed to the following address:

- The replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- Power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
