Pacific Gas and Electric Company (“PG&E” or “the Company”) hereby submits notice pursuant to General Order (“G.O.”) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

In order to improve electric service reliability to the City of Gridley and unincorporated areas of Butte County, and to support improvements to the Peachton Substation at 99 Ord Ranch Road in Butte County, PG&E proposes to install a bypass switch on the Table Mountain–Pease 60 Kilovolt (kV) Power Line. To install the bypass switch, PG&E will replace two existing 65- to 75-foot-tall wood poles with two new 75-foot-tall tubular steel poles, and will install a new 52-foot-long power line span across Ord Ranch Road between the new poles. The two new tubular steel poles will be located directly across the street from each other on either side of Ord Ranch Road (existing franchise), east of Highway 99 and approximately 164 feet west of the substation. Each tubular steel pole will be installed with new foundations approximately 5 feet in diameter. Work is scheduled to begin in September 2011, or as soon thereafter as possible, and will be completed by December 2011, or as soon thereafter as possible.

CPUC General Order 131-D, Section III.B.1, exempts projects meeting specific conditions from the CPUC’s requirement to file an application requesting

authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption(s):

- g. Power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Additionally, G.O. 131-D requires utilities to employ "no cost" and specified "low cost" measures to reduce public exposure to electric and magnetic fields ("EMFs") in accordance with CPUC Decision 06-01-042 and the "EMF Guidelines for Electrical Facilities." The following measures are proposed for this project:

- Because there are no EMF mitigation measures available on this project that would meet the CPUC's benchmark of 4% or less of the total project cost, no "no cost" or "low-cost" measures will be employed.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

NOTICE OF PROPOSED CONSTRUCTION

PROJECT NAME: TABLE MOUNTAIN–PEASE 60 KV POWER LINE BYPASS SWITCH PROJECT (BUTTE COUNTY)

ADVICE LETTER NUMBER: 3888-E

Proposed Project: In order to improve electric service reliability to the City of Gridley and unincorporated areas of Butte County, and to support improvements to the Peachton Substation at 99 Ord Ranch Road in Butte County, Pacific Gas and Electric Company (PG&E) proposes to install a bypass switch on the Table Mountain–Pease 60 Kilovolt (kV) Power Line. To install the bypass switch, PG&E will replace two existing 65- to 75-foot-tall wood poles with two new 75-foot-tall tubular steel poles, and will install a new 52-foot-long power line span across Ord Ranch Road between the new poles. The two new tubular steel poles will be located directly across the street from each other on either side of Ord Ranch Road (existing franchise), east of Highway 99 and approximately 164 feet west of the substation. Each tubular steel pole will be installed with new foundations approximately 5 feet in diameter. Work is scheduled to begin in September 2011, or as soon thereafter as possible, and will be completed by December 2011, or as soon thereafter as possible.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III.B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption(s):

- g. Power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

- 1. Your name, mailing address and daytime telephone number.
- 2. Reference to the CPUC Advice Letter Number and Project Name.
- 3. A clear description of the reason for the protest.
- 4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
