Subject: Submits Notice of Construction, Pursuant to General Order 131-D, for the Construction of Holly Sugar Sports Park 115 KV Power Line Relocation in the City of Tracy and San Joaquin County

Pacific Gas and Electric Company ("PG&E" or "the Company") hereby submits notice pursuant to General Order ("G.O.") 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

To accommodate road-widening improvements to Tracy Boulevard associated with the Holly Sugar Sports Park, PG&E has been requested to relocate approximately 2,316 feet of the Telsa-Tracy 115 Kilovolt (kV) Power Line on the west side of Tracy Boulevard, north of Larch Road, in San Joaquin County. PG&E will relocate the power line approximately 44 feet of west of its current location outside of the existing road right-of-way onto land owned by the City of Tracy. The project will replace 7 existing wood poles (approximately 65-75 feet tall) with 7 new wood poles approximately the same height or up to approximately 15 feet taller (replacement of existing facilities). Work is scheduled to begin in December 2011, or as soon thereafter as possible, and will be completed by the end of March 2012, or as soon thereafter as possible.

CPUC General Order 131-D, Section III, Subsection B.1.b, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption(s):

“The replacement of existing power line facilities or supporting structures with equivalent facilities or structures.”

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

Anyone wishing to protest this filing may do so by filing a protest with the CPUC and the Company by **November 3, 2011**, which is 20 days after the date of this filing. Protests should be mailed to the following address:

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- a. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- b. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

- 1. Your name, mailing address and daytime telephone number.
- 2. Reference to the CPUC Advice Letter Number and Project Name.
- 3. A clear description of the reason for the protest.
- 4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
