Pacific Gas and Electric Company ("PG&E" or "the Company") hereby submits notice pursuant to General Order ("G.O.") 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Certificate of Public Convenience and Necessity.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

PG&E has been requested by NextEra Energy to rearrange the existing High Winds and Montezuma I wind projects' 230kV generation tie lines (gen ties) to accommodate a third wind generation project, the 78.2-megawatt Montezuma II Wind Project. For the rearrangement, the customer will route the two existing gen ties and a new 230 kV gen tie into the new, customer-owned Montezuma II Substation, from which PG&E's relocated 230 kV interconnecting line will extend. To accomplish this interconnection, PG&E will remove two spans of 230kV conductor (approximately 100' in length each) and add four spans of 230kV conductor (approximately 825' in length). Construction is expected to take place in late 2011, or as soon thereafter as possible.

CPUC General Order 131-D, Section III, Subsection A, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption(s):

- Minor relocation of existing power line facilities.

Additionally, G.O. 131-D requires utilities to employ "no cost" and specified "low cost" measures to reduce public exposure to electric and magnetic fields ("EMFs") in accordance with CPUC Decision 06-01-042 and the "EMF Guidelines for Electrical Facilities." The following measures are proposed for this project:

- Because there are no EMF mitigation measures available on this project that would meet the CPUC's benchmark of 4% or less of the total project cost, no "no cost" or "low-cost" measures will be employed.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

Proposed Project: PG&E has been requested by NextEra Energy to rearrange the existing High Winds and Montezuma I wind projects' 230kV generation tie lines (gen ties) to accommodate a third wind generation project, the 78.2-megawatt Montezuma II Wind Project. For the rearrangement, the customer will route the two existing gen ties and a new 230 kV gen tie into the new, customer-owned Montezuma II Substation, from which PG&E's relocated 230 kV interconnecting line will extend. To accomplish this interconnection, PG&E will remove two spans of 230kV conductor (approximately 100' in length each) and add four spans of 230kV conductor (approximately 825' in length). Construction is expected to take place in late 2011, or as soon thereafter as possible.

Electric and Magnetic Fields (EMF): Pacific Gas and Electric Company will employ "no cost" and specified "low cost" measures to reduce public exposure to EMF in accordance with California Public Utilities Commission (CPUC) Decision 06-01-042 and Pacific Gas and Electric Company's "EMF Design Guidelines for Electrical Facilities." The following measures are proposed for this project:

- Because there are no EMF mitigation measures available on this project that would meet the CPUC's benchmark of 4% or less of the total project cost, no "no cost" or "low-cost" measures will be employed.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III.A, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption:

- Minor relocation of existing power line facilities.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may impact an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.

Within 30 days after Pacific Gas and Electric Company has submitted its response, the Executive Director of the CPUC will send you a copy of an Executive Resolution granting or denying the request and stating the reasons for the decision.
