Pacific Gas and Electric Company ("PG&E" or "the Company") hereby submits notice pursuant to General Order ("G.O.") 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

PG&E has been requested by California Department of Transportation ("Caltrans") to replace six lattice steel structures on the Contra Costa-Shell Contra Costa #1 60 Kilovolt ("kV") Power Line and one lattice steel structure on the Contra Costa #1 115 kV Power Line in order to accommodate the expansion of Highway 4 (replacement of existing facilities). The new structures will be tubular steel poles, which will have a sufficiently smaller footprint to accommodate the highway expansion without relocating the power lines from their current alignments (existing easement). On the Contra Costa-Shell 60 kV Power Line, which parallels Highway 4, three structures will be replaced on the south side of Highway 4 where the power line crosses Lone Tree Way, and three structures will be replaced on the north side of Highway 4 where the power line parallels Sunset Drive. On the Contra Costa #1 115 kV Power Line, which runs perpendicular to Highway 4, one tower will be replaced on the north side of Highway 4 where the power line crosses the highway and Sunset Drive. The new tubular steel poles will be up to approximately 8 feet taller than the existing lattice steel structures, and will be placed within approximately 10 feet of the existing structures, which will be removed. Construction is expected to begin in January 2012, or as soon as possible thereafter, and be completed by December 2013, or as soon as possible thereafter.

CPUC General Order 131-D, Section III, Subsection B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption(s):

"The replacement of existing power line facilities or supporting structures with equivalent facilities or structures."

"Power lines or substations to be relocated or constructed which have undergone environmental review pursuant to CEQA as part of a larger project, and for which the final CEQA document (Environmental Impact Report ("EIR") or Negative Declaration) finds no significant unavoidable environmental impacts caused by the proposed line or substation."

Caltrans has adopted a Negative Declaration for the widening of Highway 4 from Loveridge Road to Highway 160, finding no significant unavoidable environmental impacts resulting from the relocation of PG&E's facilities (State Clearinghouse #2004092135).

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

NOTICE OF PROPOSED CONSTRUCTION

PROJECT NAME: Contra Costa - Shell 60 kV Power Line Tower Replacement Project, Phase III (City of Antioch)

ADVICE LETTER NUMBER: 3964-E

Proposed Project: Pacific Gas and Electric Company (PG&E) has been requested by California Department of Transportation (Caltrans) to replace six lattice steel structures on the Contra Costa–Shell Contra Costa #1 60 Kilovolt (kV) Power Line and one lattice steel structure on the Contra Costa #1 115 kV Power Line in order to accommodate the expansion of Highway 4 (replacement of existing facilities). The new structures will be tubular steel poles, which will have a sufficiently smaller footprint to accommodate the highway expansion without relocating the power lines from their current alignments (existing easement). On the Contra Costa–Shell 60 kV Power Line, which parallels Highway 4, three structures will be replaced on the south side of Highway 4 where the power line crosses Lone Tree Way, and three structures will be replaced on the north side of Highway 4 where the power line parallels Sunset Drive. On the Contra Costa #1 115 kV Power Line, which runs perpendicular to Highway 4, one tower will be replaced on the north side of Highway 4 where the power line crosses the highway and Sunset Drive. Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III.B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. PG&E believes this project qualifies for the following exemption:

- b. The replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- g. Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

- 1. Your name, mailing address and daytime telephone number.
- 2. Reference to the CPUC Advice Letter Number and Project Name.
- 3. A clear description of the reason for the protest.
- 4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
