Pacific Gas and Electric Company ("PG&E" or "the Company") hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

In order to maintain safe and reliable electrical service, Pacific Gas and Electric Company (PG&E) proposes to replace three lattice steel poles (replacement of existing facilities) with three new lattice steel poles and remove one pole along the Del Monte #1 60 Kilovolt (kV) Power Line in the City of Seaside. The affected power line segment is located approximately 500 feet east of General Jim Moore Boulevard between Metz Road and Eucalyptus Road. The new poles will be approximately 20 feet taller to comply with CPUC General Order 95 ground-to-conductor clearance requirements and avian protection standards. Poles will generally be replaced adjacent to the existing pole locations, within the current easement (existing easement). One pole near Metz Road will be moved approximately 40 feet to avoid damage of a mature tree. Work is scheduled to begin in March 2012, or as soon thereafter as possible, and will be completed in approximately 1 month.

CPUC General Order 131-D, Section III, Subsection B.1.b,g, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for

the following exemptions, "the replacement of existing power line facilities or supporting structures with equivalent facilities or structures", and "power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts."

Additionally, G.O. 131-D requires utilities to employ "no cost" and specified "low cost" measures to reduce public exposure to electric and magnetic fields (EMFs) in accordance with CPUC Decision 06-01-042 and the "EMF Guidelines for Electrical Facilities." The following measures are proposed for this project:

- Because there are no EMF mitigation measures available on this project that would meet the CPUC's benchmark of 4% or less of the total project cost, no "no cost" or "low-cost" measures will be employed.

If exempt under EMF Guidelines, omit above section.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

ADVICE LETTER NUMBER: 3991-E

Proposed Project: In order to maintain safe and reliable electrical service, Pacific Gas and Electric Company (PG&E) proposes to replace three lattice steel poles (replacement of existing facilities) with three new lattice steel poles and remove one pole along the Del Monte #1 60 Kilovolt (kV) Power Line in the City of Seaside. The affected power line segment is located approximately 500 feet east of General Jim Moore Boulevard between Metz Road and Eucalyptus Road. The new poles will be approximately 20 feet taller to comply with CPUC General Order 95 ground-to-conductor clearance requirements and avian protection standards. Poles will generally be replaced adjacent to the existing pole locations, within the current easement (existing easement). One pole near Metz Road will be moved approximately 40 feet to avoid damage of a mature tree. Work is scheduled to begin in March 2012, or as soon thereafter as possible, and will be completed in approximately 1 month.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III.B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. PG&E believes this project qualifies for the following exemption(s):

- b) The replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- g) Power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
