Pacific Gas and Electric Company ("PG&E" or "the Company") hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

To accommodate a new traffic signal, the City of San Jose has requested PG&E to relocate and reconstruct approximately 450 feet of the existing 115 Kilovolt (kV) Maybury Tap (existing franchise) at the intersection of Berryessa Road and Flickinger Avenue (North Jackson Avenue) in San Jose. PG&E will replace an existing wood pole located on the northwest side of Berryessa Road approximately 170 feet southwest of the intersection. The next consecutive pole to the northeast will be relocated approximately 50 feet northeast (minor relocation) from its current location in the right-turn median to the northwest side of Berryessa Road. Both new wood poles will be approximately 15 feet taller to accommodate sufficient clearance over the new traffic signal facilities. PG&E will also replace pole hardware on an existing pole located on the northeast side of Flickinger Avenue approximately 150 feet northwest of the intersection. Construction is proposed to begin April 2012 or as soon as possible thereafter, and project completion is scheduled for May 2012 or as soon as possible thereafter.

CPUC General Order 131-D, Section III, Subsection B.1.x, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption(s),

- c. the minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.

- g. power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Protests

Anyone wishing to protest this filing may do so by filing a protest with the CPUC and the Company by **February 27, 2012**, which is 20 days after the date of this filing. Protests should be mailed to the following address:

Proposed Project: To accommodate a new traffic signal, the City of San Jose has requested PG&E to relocate and reconstruct approximately 450 feet of the existing 115 Kilovolt (kV) Maybury Tap (existing franchise) at the intersection of Berryessa Road and Flickinger Avenue (North Jackson Avenue) in San Jose. PG&E will replace an existing wood pole located on the northwest side of Berryessa Road approximately 170 feet southwest of the intersection. The next consecutive pole to the northeast will be relocated approximately 50 feet northeast (minor relocation) from its current location in the right-turn median to the northwest side of Berryessa Road. Both new wood poles will be approximately 15 feet taller to accommodate sufficient clearance over the new traffic signal facilities. PG&E will also replace pole hardware on an existing pole located on the northeast side of Flickinger Avenue approximately 150 feet northwest of the intersection. Construction is proposed to begin April 2012 or as soon as possible thereafter, and project completion is scheduled for May 2012 or as soon as possible thereafter.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III.B.1 exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption(s):

- c. the minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.
- g. power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

- 1. Your name, mailing address and daytime telephone number.
- 2. Reference to the CPUC Advice Letter Number and Project Name.
- 3. A clear description of the reason for the protest.
- 4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.

Within 30 days after Pacific Gas and Electric Company has submitted its response, the Executive Director of the CPUC will send you a copy of an Executive Resolution granting or denying the request and stating the reasons for the decision.
