Pacific Gas and Electric Company ("PG&E" or "the Company") hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

To accommodate a new, low voltage distribution line that will improve service reliability at Stadium Center, an existing retail/commercial shopping center in Manteca, PG&E proposes to replace two wood poles (replacement of existing facilities) with new wood poles and intersert three new wood poles (intersetting additional structures) so that new 17 kV wires can be added beneath the existing Tesla-Salado Manteca 115 kV Power Line (existing easement). The project is located along the west side of Airport Way in Manteca, beginning approximately 175 feet south of West Atherton Drive and extending approximately 3,000 feet north to Daniels Street. The new poles will be approximately 70 to 75 feet tall, similar to the existing poles. PG&E will also install additional cross-arms and hardware on three existing power line poles to accommodate the new 17kV wires. Work is scheduled to begin in May 2012, or as soon thereafter as possible, and will be completed by September 2012, or as soon thereafter as possible.

CPUC General Order 131-D, Section III, Subsection B.1.b. B.1.c. and B.1.g., exempts projects meeting specific conditions from the CPUC's requirement to file

an application requesting authority to construct. PG&E believes this project qualifies for the following exemption(s)

- b. the replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- c. the minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.
- g. power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant and unavoidable environmental impacts.

NOTICE OF PROPOSED CONSTRUCTION

PROJECT NAME: Tesla-Salado Manteca 115 kV Power Line Modification Project, City of Manteca
ADVICE LETTER NUMBER: 4013-E

Proposed Project: To accommodate a new, low voltage distribution line that will improve service reliability at Stadium Center, an existing retail/commercial shopping center in Manteca, PG&E proposes to replace two wood poles (replacement of existing facilities) with new wood poles and interset three new wood poles (intersetting additional structures) so that new 17 kV wires can be added beneath the existing Tesla-Salado Manteca 115 kV Power Line (existing easement). The project is located along the west side of Airport Way in Manteca, beginning approximately 175 feet south of West Atherton Drive and extending approximately 3,000 feet north to Daniels Street. The new poles will be approximately 70 to 75 feet tall, similar to the existing poles. PG&E will also install additional cross-arms and hardware on three existing power line poles to accommodate the new 17kV wires. Work is scheduled to begin in May 2012, or as soon thereafter as possible, and will be completed by September 2012, or as soon thereafter as possible.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III.B.1 exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. PG&E believes this project qualifies for the following exemptions:

- b. the replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- c. the minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.
- g. power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant and unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.

Within 30 days after Pacific Gas and Electric Company has submitted its response, the Executive Director of the CPUC will send you a copy of an Executive Resolution granting or denying the request and stating the reasons for the decision.
