Pacific Gas and Electric Company ("PG&E" or "the Company") hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

To accommodate the widening of Highway 101 in Petaluma, CalTrans has requested Pacific Gas and Electric Company (PG&E) to relocate approximately 1,341 feet (minor relocation) of the existing Lakeville-Petaluma C 60 kV Power Line. PG&E has designed the project to remove two existing poles from residential back yards. The plan is to remove four wood poles (approximately 47 to 61 feet tall), add two new wood poles approximately 57 to 70 feet tall, and replace five existing wood poles (approximately 42 to 47 feet tall) with taller (approximately 56 to 75 feet tall) wood or light-duty steel poles, which weather to resemble wood. The taller poles are needed to comply with CPUC General Order 95 minimum ground to conductor clearance requirements over the raised highway. The relocation begins in the parking lot of the Plaza North Shopping Center at 261 North McDowell Boulevard in Petaluma and extends southwesterly past the K-Mart, across Highway 101, through the side yard of a private residence, and continues up Madison Street until approximately 50 feet southwest of its intersection with Burlington Drive. Construction activities are

scheduled to begin in June 2012, or as soon thereafter as possible, with completion in August 2012 or as soon thereafter as possible.

CPUC General Order 131-D, Section III, Subsection B.1., exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption:

- c. The minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

Anyone wishing to protest this filing may do so by filing a protest with the CPUC and the Company by **May 2, 2012**, which is 20 days after the date of this filing. Protests should be mailed to the following address:

Exemption from CPUC Authority: CPUC General Order 131-D, Section III.B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption:

- c. The minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

- 1. Your name, mailing address and daytime telephone number.
- 2. Reference to the CPUC Advice Letter Number and Project Name.
- 3. A clear description of the reason for the protest.
- 4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.

Within 30 days after Pacific Gas and Electric Company has submitted its response, the Executive Director of the CPUC will send you a copy of an Executive Resolution granting or denying the request and stating the reasons for the decision.
