Subject: Submits Notice of Construction, Pursuant to General Order 131-D, for the Construction of the Tejon–Lebec 70 kV Power Line Relocation Project, County of Kern

Pacific Gas and Electric Company (“PG&E” or “the Company”) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

In order to accommodate the Tejon Ranch Company’s planned Tejon Industrial Complex East Project, PG&E has been requested to relocate a portion of the Tejon–Lebec 70 Kilovolt (kV) Power Line at the intersection of Wheeler Ridge Road and Laval Road just south of Wheeler Ridge in unincorporated Kern County. PG&E will relocate approximately 1,650 feet of the power line (minor relocation) by removing four approximately 70-foot-tall wood poles, and replacing them with two approximately 100-foot-tall tubular steel poles with foundations. One tubular steel pole will be installed on the northwest corner of the intersection, and the other will be installed approximately 785 feet due south on the east side of Interstate 5 North off ramp to Wheeler Ridge Road. Construction is expected to begin in August 2012, or as soon thereafter as possible, with completion in September 2012 or as soon as possible after construction begins.

CPUC General Order 131-D, Section III, Subsection B.1.C, exempts projects meeting specific conditions from the CPUC’s requirement to file an application

requesting authority to construct. The Company believes this project qualifies for the following exemption(s),

- c) The minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

- 1. Your name, mailing address and daytime telephone number.
- 2. Reference to the CPUC Advice Letter Number and Project Name.
- 3. A clear description of the reason for the protest.
- 4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
