Pacific Gas and Electric Company (PG&E) hereby submits for filing revisions to its California Alternate Rates for Energy (CARE) re-certification application form for residential single-family customers. The affected tariff sheets are listed on the enclosed Attachment 1.

Purpose

The purpose of this filing is to revise the eligibility criteria for re-certification for PG&E's CARE Program.

CARE Program

This filing complies with Decision (D.)12-08-044 issued August 30, 2012, in which the Commission directed the Investor Owned Utilities (IOUs) to retain the Categorical Eligibility and Enrollment Program only for the enrollment of new CARE customers. As a result of this directive, the CARE Program Re-Certification Application (Form 62-1509) for Residential Single-Family Customers has been revised, removing the Public Assistance Program Eligibility criteria.
