Pacific Gas and Electric Company ("PG&E" or "the Company") hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

In order to accommodate improvements to Brundage Lane associated with a planned retail development, PG&E has been requested to relocate approximately 1,500 feet (minor relocation) of the existing Kern-Stockdale 115 Kilovolt (kV) Power Line in the City of Bakersfield. The power line segment will be relocated approximately 27 feet south of its current alignment on the south side of Brundage Lane, east of Oswell Street. PG&E will replace two existing approximately 50-foot-tall wood poles with two approximately 55-foot-tall light-duty steel poles, which are weathered to resemble wood. In addition PG&E will remove two approximately 30-foot-tall guy stub poles and install one approximately 30-foot-tall guy stub pole. Work will commence in May 2013, or as soon as possible thereafter, and will be completed by July 2013, or as soon as possible after construction begins.

CPUC (California Public Utilities Commission) General Order 131-D, Section III, Subsection B.1, exempts projects meeting specific conditions from the CPUC's

requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption:

- c. the minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

Anyone wishing to protest this filing may do so by filing a protest with the CPUC and the Company by April 22, 2013, which is 20 days after the date of this filing. Protests should be mailed to the following address:

Proposed Project: In order to accommodate improvements to Brundage Lane associated with a planned retail development, Pacific Gas and Electric Company (PG&E) has been requested to relocate approximately 1,500 feet (minor relocation) of the existing Kern-Stockdale 115 Kilovolt (kV) Power Line in the City of Bakersfield. The power line segment will be relocated approximately 27 feet south of its current alignment on the south side of Brundage Lane, east of Oswell Street. Work will commence in May 2013, or as soon as possible thereafter, and will be completed by July 2013, or as soon as possible after construction begins.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III.B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemptions:

- c. the minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.

Within 30 days after Pacific Gas and Electric Company has submitted its response, the Executive Director of the CPUC will send you a copy of an Executive Resolution granting or denying the request and stating the reasons for the decision.
