Subject: Supplemental: Limited One Time Agreement to Perform Tariff Scheduled Related Work for the California Department of Water Resources

Pacific Gas and Electric Company (PG&E) hereby submits in this supplemental filing for a limited one time agreement modifying PG&E's standard indemnity clause as it appears on Form 62-4527. The supplemental filing is submitted to adjust the Tier classification from a Tier 1 advice to a Tier 3 advice filing.

This Supplemental Advice will replace the earlier Advice 4213-E in its entirety.

Purpose

Approval of indemnity clause as it appears in attached Limited One Time Agreement to Perform Tariff Scheduled Related Work.

Background

The California Department of Water Resources (DWR) has requested that PG&E relocate certain overhead electric distribution facilities located adjacent to the Cache Creek levee in Yolo County. DWR requested the relocation of PG&E's distribution facilities to accommodate the realignment of the Cache Creek levee. The project involves the removal of 5 poles and overhead electric conductors in conflict with the levee improvements. The line will be relocated in a new alignment that will be parallel to realigned levee, 15 feet from the toe of the levee. A replacement right of way will be provided to PG&E for the new alignment of the distribution pole line. Electric Rule 15.I.1 governs the relocation of distribution facilities. Relocation is generally performed under PG&E's general contract form, Agreement to Perform Tariff Schedule Related Work, Form 62-4527. DWR has objected to the scope of the indemnity provision in Form 62-4527, and has requested that its obligation to indemnify PG&E be limited to any losses that are caused by or result from DWR's negligent or intentional acts or omissions. To address this concern, PG&E has agreed to modify the indemnity language found in

Form 62-4527 and to use revised language in a limited One Time Agreement to Perform Tariff Scheduled Related Work.



STATE OF CALIFORNIA, DEPARTMENT OF WATER RESOURCES, A Government Agency (Applicant) has requested PACIFIC GAS AND ELECTRIC COMPANY, a California corporation (PG&E), to perform the tariff schedule related work as located and described in paragraph 3 herein. PG&E agrees to perform the requested work and furnish all necessary labor, equipment, materials and related facilities required therefore, subject to the following conditions:

1. Whenever part or all of the requested work is to be furnished or performed upon property other than that of Applicant, Applicant shall first procure from such owners all necessary rights-of-way and/or permits in a form satisfactory to PG&E and without cost to it.
2. Applicant shall indemnify and hold harmless PG&E, its officers, agents and employees, against all loss, damage, expense and liability resulting from injury to or death of any person, including but not limited to, employees of PG&E, Applicant or any third party, or for the loss, destruction or damage to property, including, but not limited to property of PG&E, Applicant or any third party, arising out of or in any way connected with the performance of this agreement, however caused, except to the extent caused by the fault or negligence of PG&E, its officers, agents and employees. Applicant will pay all costs that may be incurred by PG&E in enforcing this indemnity, including reasonable attorneys' fees.
