Public Utilities Commission of the State of California

Subject: Notification of the Creation of Four New Affiliates

Purpose

In accordance with Decision 97-12-088, Appendix A, Rule VI. B--New Affiliate Compliance Plans, Pacific Gas and Electric Company hereby notifies the Commission of the formation of four new affiliates, as defined by the Affiliate Transaction Rules.
