(Pacific Gas and Electric Company ID U 39 M)

Public Utilities Commission of the State of California

**Subject: Notification of the Creation of New Affiliate**

**Purpose**

In accordance with Decision 97-12-088, Appendix A, Rule VI. B--New Affiliate Compliance Plans, Pacific Gas and Electric Company hereby notifies the Commission of the formation of a new affiliate, as defined by the Affiliate Transaction Rules.

Rule VI. B. Specifically requires that:

Upon creation of a new affiliate, which is addressed by these Rules, the utility shall immediately notify the Commission of the creation of the new affiliate, as well as posting notice on its electronic bulletin board. No later than 60 days after the creation of this affiliate, the utility shall file an advice letter with the Energy Division of the Commission, served on parties to this proceeding. The advice letter shall demonstrate how the utility will implement these Rules with respect to the new affiliate.

**Liberty Urban Renewal, LLC**

Liberty Urban Renewal, LLC was formed on August 3, 2000, to own and lease the Liberty Generating Project to be located in Linden, New Jersey, and to operate under the Long Term Exemption Law, N.J.S.A. 0A:20-1 et seq., as amended. Company's most recently filed Affiliate Rules Compliance Plan (Advice 2202-G/1947-E). The affiliate rules will apply to this affiliate. Therefore, Pacific Gas and Electric Company will apply all the provisions of its Affiliate Rules Compliance Plan to all transactions with this new affiliate.

This filing will not increase any other rate or charge, cause the withdrawal of service, or conflict with any rate schedule or rule.

### **Protests**

Anyone wishing to protest this filing may do so by sending a letter within 20 days of the date of this filing. The protest must state the grounds upon which it is based, including such items as financial and service impact, and should be submitted expeditiously.
