**Subject: January 2001 Core Procurement Rate Changes**

Pacific Gas and Electric Company (the Company) hereby submits for filing revisions to its gas tariffs. The affected tariff sheets are listed on the enclosed Attachment I.

**Purpose**

The purpose of this filing is to submit changes to core end-use customer gas rates effective **January 5, 2001**. This filing is submitted in compliance with Decision (D.) 97-10-065, which approved monthly price changes for core gas procurement rates, and also incorporates changes to core rates pursuant to Gas Accord D. 97-08-055 and Biennial Cost Allocation Proceeding (BCAP) D. 98-06-073.

**2001 Gas Accord Adjustment**

On November 30, 2000, PG&E filed Advice 2281-G which in accordance with Gas Accord D. 97-08-055, provides for annual adjustments to local and backbone transmission charges, customer access charges, bundled core storage, load balancing storage and parking and lending rates, effective January 1st of each year during the Gas Accord period. The Gas Accord rate adjustments for core transportation rates, as presented in Advice 2281-G, are incorporated in this filing for rates effective January 5, 2001.

**January Rates**

The Company is revising the gas procurement charges shown on core end-use customer Schedules G-1, GM, GS, GT, GL-1, GML, GSL, GTL, G-NR1, G-NR2, G-NGV1, G-NGV2 and G-CP--*Gas Procurement Service to Core End-Use Customers*. The procurement charges shown on Schedule G-CP are for illustrative purposes only and are the same as those shown on the end-use customer schedules. The gas procurement rate varies by rate schedule due to the allocation of capacity charges to the core customer classes.

The Company has been educating customers about the rising gas market prices and has been providing information about how to conserve energy and obtain financial assistance to pay bills through various communications, including a letter sent to its customers.

The Schedule G-CP rates effective **January 5, 2001**, include:

- a) A monthly core commodity charge of **\$0.89640** per therm, compared to last month's commodity charge of **\$0.63200** per therm. The commodity charge includes backbone transportation charges to the citygate.
- b) An adjustment of **\$0.34032** per therm, which amortizes a \$153.1 million undercollection in the core sales subaccount of the Purchased Gas Account (PGA) over one month.
- c) An adjustment of **\$0.06431** per therm, which amortizes a \$28.9 million undercollection in the core shrinkage account over one month.
- d) An adjustment to the interstate and backbone capacity charges to account for the monthly election of backbone and interstate capacity by Core Transport Agent.
- e) A core storage rate component, adjusted to account for elections of core firm storage capacity by Core Transport Agents.

Preliminary Statement, Part B—*Default Tariff Rate Components*, reflects changes to the core procurement components. Workpapers showing the derivation of rates and components in this advice filing can be obtained by writing to the address shown below.
