Subject: July 2001 G-SUR Rate

Pacific Gas and Electric Company (the Company) hereby submits for filing revisions to its gas tariffs. The affected tariff sheets are listed on the enclosed Attachment I.¹

Purpose

The purpose of this filing is to submit the Schedule G-SUR rate change effective **July 1, 2001**.

Pursuant to Public Utilities Code Sections 6350-6354, gas volumes procured by customers from third-party entities and transported by PG&E may be subject to a gas franchise fee surcharge under Schedule G-SUR--*Customer-Procured Gas Franchise Fee Surcharge*. The franchise fee surcharge is calculated based on the core Weighted Average Cost of Gas (WACOG) for the previous month, exclusive of storage costs and franchise fees, and including uncollectibles, multiplied by the franchise fee factor adopted in PG&E's most recent General Rate Case.²

Effective **July 1, 2001**, the G-SUR franchise fee surcharge is **\$0.00628** per therm.

¹ PG&E reserves all legal rights to challenge the decisions or statutes under which it has been required to make this advice filing, and nothing in this advice filing constitutes a waiver of such rights. Also, PG&E reserves any additional legal rights to challenge the requirement to make this advice filing by reason of its status as a debtor under Chapter 11 of the Bankruptcy Code, and nothing in this advice filing constitutes a waiver of such rights.

² The Schedule G-SUR rate previously was calculated using the core subscription WACOG, which did not include storage costs. In accordance with Gas Accord Settlement Decision 97-08-055, effective February 28, 2001, service under Schedule G-CSP—*Core Subscription Gas Procurement Service to Noncore End-Use Customers*, is terminated. Therefore, the Schedule G-SUR rate is now calculated using the core WACOG excluding storage costs, which is equivalent to the former core subscription WACOG.

SCHEDULE G-SUR—CUSTOMER-PROCURED GAS FRANCHISE FEE SURCHARGE

APPLICABILITY: Pursuant to California State Senate Bill No. 278 (1993) this schedule applies to all gas volumes procured by Customers from third-party entities and transported by PG&E ("Customer-procured gas") with the following exceptions:

- a. the State of California or a political subdivision thereof;
- b. one gas utility transporting gas for end use in its Commission-designated service area through another utility's service area;
- c. a utility transporting its own gas through its own gas transmission and distribution system for purposes of generating electricity or for use in its own operations;
- d. cogeneration Customers, for that quantity of natural gas currently defined as the Cogeneration Gas Allowance (CGA).

TERRITORY: Schedule G-SUR applies everywhere PG&E provides natural gas service.

RATES: The Customer-procured gas Franchise Fee Surcharge is comprised of the following components:

- a. the monthly core Weighted Average Cost of Gas (WACOG) for the prior month, exclusive of storage costs and Franchise Fees, and including Uncollectibles, which is Per Therm

multiplied by

- b. the Franchise Fee factor* adopted in PG&E's most recent General Rate Case, which is 0.014997

The G-SUR Franchise Fee Surcharge for **July 2001** is \$0.00628 (R) (T)

SURCHARGE RECOVERY: The surcharge will be shown on the Customer's monthly bill based on volumes procured by the Customer from a third party and transported by PG&E (metered usage).

DELINQUENT SURCHARGES: In the event that payment on a transportation Customer account becomes more than 90 days delinquent, PG&E shall, within 30 days, notify the municipality of the delinquency and provide information on the name and address of the delinquent transportation Customer and the surcharge amount owed. PG&E shall not be liable for delinquent surcharges.

* Does not include Uncollectibles factor of 0.003431.
