**Subject: Revisions to Form 79-1018—Residential Rule 16 Electric/Gas
Single Service Extensions**

Public Utilities Commission of the State of California

Pacific Gas and Electric Company (PG&E) hereby submits for filing revisions to Form 79-1018—Residential Rule 16 Electric/Gas Single Service Extensions, for its gas and electric line extension tariffs for certain single services under Rule 16--*Electric/Gas Service Extensions*. The affected tariff sheets are listed on the enclosed Attachment I.

Purpose

Form 79-1018 provides an easy-to-use two-page letter agreement for specified residential Rule 16 services.¹ PG&E hereby proposes to modify Form 79-1018 to advise the applicant of its choice to design its single service facility or to select PG&E to do the design. Although most single service applicants choose PG&E to design the service to their house, PG&E's revision reiterates their options. The revised form also sets forth the amount of "Design Credit" PG&E will pay if the applicant chooses to design its own single service facility.

PG&E also proposes a sixty-day period after approval of this filing to allow PG&E time to update its training materials and roll out the new form in an orderly manner to PG&E's field personnel.

Proposed Revisions to Form 79-1018

PG&E proposes the following clarifying revisions to Form 79-1018:

1. Revise the second sentence on page 1 of Form 79-1018 to read, "... by contacting me" instead of "your PG&E representative...".

2. Revise the last sentence of the second paragraph on page 1 to read, "... return the completed SACAC form to **"me"** instead of "PG&E."
3. In the last bullet on page 1, add the language shown in bold as follows: "...along with a check for \$ ____ **to me at the address shown on the second page.**
4. Move the sentence, "PG&E's costs are valid for 90 days from the date of this letter" into the last bullet on page 1 from the paragraph below it.
5. Move into the last bullet on page 1 from the paragraph below the sentence, "If payment is not received within this period, PG&E **reserves the right** to revise these costs."
6. Add a new paragraph after the last bullet on page 1 as follows: **"Also, under the Applicant Design Option provision of PG&E's Gas and/or Electric Rules 15 and 16, you have a choice to design that portion of the new service extension normally designed by PG&E. Should you select this option your Design Credit for this job is \$ _____. PG&E's Applicant Design guidelines are available upon request. Please email or contact me confirming your choice."**
7. Add new sentence on page 1 as follows: **"PG&E will energize and/or pressurize electric/gas service to your facility following local jurisdictional approval of your facilities to ensure that they have been installed and inspected in accordance with any applicable laws, codes, ordinances, rules or regulations and are safe to energize and/or pressurize."**
8. On the second page add blanks to identify the PG&E representative and give that person's phone number and email and mailing addresses.
