Public Utilities Commission of the State of California

Pacific Gas and Electric Company (PG&E) hereby submits for filing revisions to its gas and electric Form 62-4042 – *Surety Bond/Bill Guaranty*. The affected tariff sheets are listed on the enclosed Attachment I.

**Purpose**

The purpose of this filing is to revise PG&E's gas and electric forms for Form 62-4042 – *Surety Bond/Bill Guaranty* to remove requirements for obsolete information and make the form consistent with other company practices.

**Tariff Revisions**

- Elimination of the notary requirement as customers will be asked for photocopy of their California Driver's License or State Identification Card.
- In the Office Use Only box, elimination of areas for information no longer needed, including Social Security Number (SSN) and California Driver License number as the photocopy described above will suffice.
- Insertion of "I declare a penalty of perjury..." statement to ensure the customer is aware of their responsibility as they will no longer be requested to appear in person to verify their identity for completion of this form.
