Purpose

In accordance with Rule VI.A. of the Commission's Affiliate Rules (adopted in Decision (D.) 98-08-035), Pacific Gas and Electric Company hereby submits an updated Affiliate Rules Compliance Plan (Compliance Plan). The Compliance Plan and its attachments are attached to this filing.

Pacific Gas and Electric Company most recently updated the Compliance Plan by Advice 2690-G/2758-E dated December 20, 2005. Pacific Gas and Electric Company hereby submits for filing amended sections of its Compliance Plan. The amended sections are Rule V.G., and Attachments D and E. Pacific Gas and Electric Company is filing these amendments to: 1) reflect changes to the list of shared officers and directors; 2) update the list of entities within the PG&E Corporation family that meet the definition for affiliate provided in Rule I.A. 3) update the Affiliated Company Transactions Procedures to reflect a change in the time entry system.

This filing will not increase any other rate or change, cause the withdrawal of service, or conflict with any rate schedule or rule.
