**Subject: April 1, 2013 Gas Core Procurement, Transportation, Residential Winter Gas Savings (WGSP) and Core Deaveraging Rate Changes**

Pacific Gas and Electric Company ("PG&E") hereby submits for filing, revisions to its gas tariffs. The affected tariff sheets are included in Attachment I to this filing.

**Purpose**

The purpose of this filing is to submit changes to PG&E's core end-use customer gas rates effective **April 1, 2013**. Specifically, this filing revises PG&E's gas procurement rates for core customers.

In addition, as described in PG&E's Advice Letter 3374-G, this Advice Letter implements:

1. Revisions to PG&E's residential and small commercial gas transportation rates for an additional 5% annual phase-in of core deaveraging in compliance with PG&E's 2010 Biennial Cost Allocation (BCAP) Decision (D.) 10-06-035;
2. Revisions to PG&E's core gas transportation rates to recover 2013 Winter Gas Savings Program (WGSP) costs from residential customers during the summer season, as filed and approved in Advice Letters (AL) 3222-G and 3353-G;
3. Revisions to PG&E's core local transmission rates for the recovery of AB32-related gas compressor station costs, as authorized in D.13-03-017; and
4. Revisions to core transportation rates associated with the GT&S Revenue Sharing Mechanism account balance implemented in PG&E's 2013 Annual Gas True-Up (AGT) AL 3353-G.

Finally, this Advice Letter revises PG&E's core gas Rate Schedules G-NR1 - "Gas Service to Small Commercial Customers" and G-NR2 - "Gas Service to Large Commercial Customers" to include the following Air Resources Board (ARB) AB32 Cost of Implementation (COI) fee exemption language:

"Customers who are directly billed by Air Resources Board (ARB) for ARB AB32 Administration Fees are exempt from PG&E's ARB AB32 Cost of Implementation (COI) rate component. Customers on the Directly Billed list, as provided annually by the ARB, may change from year to year. The exemption credit will be equal to PG&E's currently-effective ARB AB32 COI per-therm rate component (as shown in PG&E's Preliminary Statement, Part B – "Default Tariff Rate Components"), times the customer's billed volumes (therms) for each billing period."

This filing is submitted in compliance with D. 97-10-065, which approved monthly changes for gas procurement rates for core customers. Consistent with D. 98-07-025, PG&E's core procurement rates changes are made effective no later than the fifth business day of the month.<sup>1</sup>

### **Procurement Rate Changes**

PG&E is revising the gas procurement charges shown on core end-use customer Schedules G-1, G1-NGV, GM, GS, GT, GL-1, GL1-NGV, GML, GSL, GTL, G-NR1, G-NR2, G-NGV1, G-NGV2 and G-CP—*Gas Procurement Service to Core End-Use Customers*. The procurement charges shown on Schedule G-CP are for illustrative purposes only and are the same as those shown on the end-use customer schedules. The gas procurement rate varies by rate schedule due to the allocation of capacity charges and winter gas savings program costs to the core customer classes.

Schedule G-CP procurement charges proposed in this filing are shown below:

The Schedule G-CP rates effective **April 1, 2013**, reflect:

1. A monthly weighted average cost of gas (“WACOG”) of \$0.37958 per therm, compared to last month’s WACOG of \$0.30973 per therm;
2. A credit of \$0.00852 per therm to amortize over 1 month a \$1.5 million over-collection in the Core Sales subaccount of the Purchased Gas Account (“PGA”);
3. A credit of \$0.00503 per therm to amortize over 1 month a \$893 thousand over-collection in the Core Shrinkage subaccount of the PGA;
4. A credit of \$0.00254 per therm to amortize over 12 months a \$6.0 million over-collection in the Core Firm Storage Account;
5. A credit of \$0.01024 per therm to amortize over 12 months a \$24.3 million over-collection in the Core Pipeline Demand Charge Account; and
6. A charge of \$0.01894 per therm for residential, a charge of \$0.00661 per therm for small commercial, and a charge of \$0.00746 per therm for large commercial customers to collect procurement-related marketing costs and program rebates associated with PG&E’s 2012 Winter Gas Savings Program (“WGSP”)<sup>2</sup> and to continue amortization over twelve months of a \$2.4 million over-collection in the Winter Gas Savings subaccount of the PGA.

### **Effective Date**

In accordance with D. 97-10-065 and D. 98-07-025, PG&E requests that this advice filing be approved effective **April 1, 2013**.
