Purpose

PG&E is requesting revisions to the Sample Form No. 79-1099, Property Manager Authorization to Receive Owner Information or Act on an Owner's Behalf, that restructures the information being requested and the format of the form to make it more concise and easier for customers to use.

Background

Form 79-1099 was first approved with Advice 2821-G-A/3015-E-A (April 2007) to provide property owners the ability to authorize a property manager to manage all aspects of the property owner's PG&E gas and electric service(s). The form was later modified in Advice 2851-G/3088-E (July 2007) to give property owners the ability to authorize property managers to manage not only existing but also future accounts and services addresses under the owner's name.

The revisions that are being submitted today help streamline the form and further simplify the form for the customers.

Tariff Revisions

The intent of the revisions to Form 79-1099 are two-fold: (1) make the form easier and more convenient for customers by eliminating redundant or duplicative provisions; and (2) eliminate the requirement that the authorized property manager also sign the form.

PG&E is already moving toward streamlining the process for customers to directly authorize third-parties to access customer energy usage data, such as the "Green Button" application and PG&E's MyEnergy website. It makes sense to streamline similar forms such as Form 79-1099 that require customer authorization and designation of third-parties for access to customer energy usage and billing information for specialized purposes. Form 79-1099 grants a customer's property manager access to the customer's billing and usage information for purposes of managing the customer's property on behalf of the customer.

Under this streamlined approach, the customer need only formally authorize the property manager to act as the customer's agent for purposes of accessing the customer's PG&E account information, and the property manager need not sign the Property Manager Authorization form as long as the customer's authorization is valid and authenticated by PG&E. In addition, most customers are likely to request a general authorization for their property manager to access billing and account information on behalf of the customer, so the choices on the form available to the customer can be consolidated and condensed for the convenience and ease of understanding by the customer.

PG&E requests approval of this revised, streamlined Form 79-1099 as an improvement and convenience for customers, and as consistent with PG&E's overall goal of enabling customers to make their own voluntary choices and exercise their own control over the management of their PG&E services.

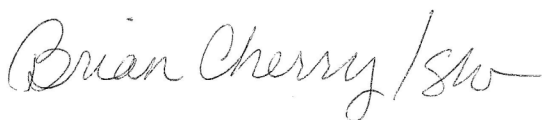
