

Gas Rate Advisory **EFFECTIVE SEPTEMBER 1, 2025**

Important update about gas rates

Throughout the year, Pacific Gas and Electric Company (PG&E) submits requests to the California Public Utilities Commission (CPUC) to change our rates. On August 25, 2025, PG&E submitted Advice Letter 5099-G¹ updating gas rates effective September 1, 2025. PG&E's bundled residential average gas CARE and Non-CARE rates will decrease by approximately \$0.01, representing a 0.4% decrease for the typical CARE and Non-CARE bundled residential customer².

PREVIOUS Residential Bundled CARE and Non-CARE Rates³ as of **August 1, 2025**, were \$2.274 and \$2.884 per therm

NEW Residential Bundled CARE and Non-CARE Rates⁴ as of **September 1, 2025**, are \$2.264 and \$2.871 per therm

Customers enrolled in the CARE program receive a discount of approximately 20% on their gas bill.


Why are rates decreasing?

The primary drivers for the September 1, 2025, rate decrease is:

The filing of Advice Letter 5099-G, which reduces rates to reflect the conclusion of revenue requirement recovery associated with the 2021 Wildfire Mitigation and Catastrophic Event (WMCE) adopted in Commission decision D.23-08-027. The WMCE account tracks costs PG&E has already spent to reduce wildfire risks, respond to major storms and emergencies and support customers during planned power shutoffs and other safety-related events.

How are rates set?

Rates are set through a regulatory process with the CPUC. The process includes opportunities for the public to attend hearings and/or provide comment. A simplified diagram of the process is shown below.
