<b>How will I be billed for PG&amp;E's Solar Choice Program?</b>	You will be billed for PG&E's Solar Choice Program on your monthly PG&E electricity bill. PG&E's Solar Choice Program charges and credits will be listed as separate line items and are in addition to your regular electricity charges.
<b>How will my PG&amp;E's Solar Choice bill be calculated?</b>	<p>Your PG&amp;E's Solar Choice bill is calculated with a <b>Solar Charge</b>, a <b>Program Charge</b>, a <b>Power Charge Indifference Adjustment</b>, and a <b>Generation Credit</b>:</p> <ul style="list-style-type: none"> <li>The <b>Solar Charge</b> is the cost of the renewable power.</li> <li>The <b>Program Charge</b> is set to fund the program's marketing and administration costs as well as to cover additional energy-related costs to ensure that non-participating customers do not fund the program. These energy-related costs include: costs associated with integrating the new renewable resources into the grid (Renewables Integration Charge), state-level grid management costs (California Independent System Operator), costs for registering, tracking and retiring Renewable Energy Certificates (RECs) in the Western Renewable Energy Generation Information System (WREGIS), Resource Adequacy (RA) costs, and a credit or charge for the positive or negative value that solar provides in delivering energy to the grid during peak hours (Solar Value Adjustment).</li> <li>The <b>Power Charge Indifference Adjustment (PCIA)</b> is set to ensure stranded generation costs are not shifted to non-participating customers when you switch to PG&amp;E's Solar Choice Program. PCIA will be applied based on the date that you begin service on PG&amp;E's Solar Choice Plan. If you begin service in the first six months of the calendar year (e.g. 2020), you are assigned the prior year's vintage (i.e. 2019). If you begin service on or after July 1, you are assigned the vintage for the current year (2020 in this example).</li> <li>The <b>Generation Credit</b> is a credit equal to the average generation rate for your customer class. This credit is to recognize that your renewable energy purchase displaces the charges for the generation portfolio associated with your base rate.</li> </ul> <p>These charges and credits will be applied on a per kWh basis to either 50% or 100% of your monthly electricity usage, depending on your participation level. Applicable federal, state, and local taxes and charges still apply.</p>

<b>Will my rate change over time?</b>	PG&E's Solar Choice rates are based on current California Public Utility Commission (CPUC) approved tariffs. Rates are subject to change annually and as approved by the CPUC.
<b>What other fees might I be charged?</b>	No other fees apply.
<b>What length of agreement /contract is required?</b>	PG&E offers Solar Choice on a month-to-month basis. There is no further length of agreement or contract required.
<b>Can I cancel my participation?</b>	You may cancel your participation in PG&E's Solar Choice Program at any time and without a fee. The cancellation will become effective as of your last closed bill period. You will then be ineligible to participate in PG&E's Solar Choice Program for a period of 12 months from the date of the change (certain customers may be exempted).

<p><b>Can I change my participation level?</b></p>	<p>You may elect to change your participation level once in a 12-month period (e.g. changing from 50% to 100% and vice versa). If PG&amp;E's Solar Choice Program is closed to new customers, existing customers may change their enrollment level down only (from 100% to 50%).</p> <p>Participation level changes will apply on the first day of the next billing cycle where the billing cycle start date occurs at least five business days after the date of the customer's request. A customer request that is received within five business days of the customer's next billing cycle may result in the customer being placed on PG&amp;E's Solar Choice Program the following billing cycle.</p>
<p><b>Can I move and continue to participate in PG&amp;E's Solar Choice Program?</b></p>	<p>Yes. PG&amp;E's Solar Choice Program is portable within PG&amp;E's electric service territory. You will be considered as having continuously received service under this schedule for the purposes of determining the PCIA vintage to apply to the new service agreement.</p>
<p><b>Can I participate in both PG&amp;E's Solar Choice and Regional Choice program at the same time?</b></p>	<p>No. You may only be enrolled in either program at a time.</p>
