



Landowner Release and Permission Form for Wildfire Wood Management ("Permission Form")

I, _____, own or am legally authorized to permit work at the following property address: _____ in _____ County

(County). I request and authorize Pacific Gas and Electric Company (PG&E) and its contractors to enter my property on foot and, as appropriate, with equipment and vehicles to inspect and manage or haul cut wood from this property that meet the requirements described here, or as PG&E or its contractors determine. I understand and agree that all wood subject to management or hauling was previously cut by PG&E for public safety, electric power restoration, or to eliminate hazards that threatened PG&E electric facilities or crews during PG&E's wildfire response. I understand that in order to qualify for this wood management or hauling offer from PG&E, I must provide this executed Permission Form to PG&E. Additionally, by providing PG&E with this executed Permission Form, I am authorizing and requesting PG&E to manage or haul away all wood and brush (brush is material less than 4 inches diameter) on my property, or portions thereof, previously cut by PG&E. In exchange for PG&E's agreement to haul away the wood, I fully and completely waive and release PG&E and its contractors from any and all liability, damages and claims arising from PG&E's trimming or cutting of trees on my property, and managing or hauling of cut wood from my property, except that PG&E agrees to fix physical damage like rutting that it may cause on my property when managing or hauling wood under this Permission Form. I understand that if the wood on my property does not meet the requirements of this Permission Form, or if managing or hauling may cause a safety issue, substantial environmental or physical damage as determined by PG&E, PG&E will not and is not obligated to haul it. I understand that PG&E hauling this wood may be contingent upon County issuing PG&E appropriate permits. By providing PG&E with my contact information, I am providing PG&E and its contractor permission to contact me by email/telephone regarding this Permission Form.

Please initial and check each of the boxes to express your agreement with all the conditions of this Permission Form and return by email to wildfirewoodmanagement@pge.com or in person to a PG&E authorized contractor.

- _____ PG&E has sole discretion to determine if the wood qualifies for management or hauling under this Permission Form.
- _____ Management under this Permission Form constitutes the chipping and spreading, lopping and scattering, relocating or hauling away of wood on the ground that is greater than 4 inches in diameter (measured at the smaller end), created by PG&E in response to tree work resulting from 2020, 2021 or 2022 wildfires.
- _____ PG&E will not charge landowner for wood management or hauling. PG&E will not provide any financial compensation to the landowner for the managed or hauled wood or reimbursement for wood management or hauling the landowner may have conducted or contracted of their own accord.
- _____ Tracked or rubber tire equipment and machinery shall have access to the property when needed to perform the work.
- _____ PG&E will not rehabilitate the work zone back to pre-tree cutting or pre-wildfire conditions. PG&E will fix physical damage it causes to the property, like rutting, which is caused by managing or hauling wood under this Permission Form.
- _____ PG&E may complete the work in an extended timeframe.
- _____ This wood management and hauling offer is an exception to PG&E vegetation management work and in response to 2020, 2021 and 2022 wildfires.
- _____ PG&E has no obligation to perform large wood management or hauling for any future vegetation management work performed on this property.
